1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, it is the sense of *I Liheslaturan Guåhan* to recognize the life and
4 accomplishments of those distinguished citizens of this great island who have devoted
5 themselves to faithfully serving the best interests of our community and the needs of
6 our people; and

7 **WHEREAS**, one such distinguished citizen is Mildred “Millie” Rivera Camacho
8 began her distinguished civil service career in 1971, after her sister encouraged her to
9 take the civil service entrance exam; she began as a clerk typist for the Officer in Charge
10 of Construction Guam, and over the next fifty-plus (50+) years, rose to become a
11 financial management analyst for the Naval Facilities Engineering Systems Command
12 (NAVFAC) Marianas; and

13 **WHEREAS**, Millie’s passion for finance began during her college years,
14 excelling in accounting and bookkeeping classes in San Diego, and upon her return to

1 Guam, she was able to transition her academic success into a long and fulfilling career
2 in financial management, serving in various roles at Andersen Air Force Base, the Naval
3 Base Guam Public Works Center, and NAVFAC Marianas; and

4 **WHEREAS**, Millie’s dedication to her craft, coupled with her love for working
5 with numbers, has garnered the respect and admiration of her colleagues and superiors.
6 In August 2021, she celebrated her fiftieth (50th) year of civil service, where she was
7 honored with a golden service pin and a length of service award presented by NAVFAC
8 Marianas Commanding Officer Captain Tim Liberatore; and

9 **WHEREAS**, in March of 2024, Millie was further recognized with the
10 prestigious “*Peggy D. Craig Lifetime Service*” Award, which is presented annually to
11 individuals who personify a career of service, selflessness, and dedication to NAVFAC
12 and its mission. NAVFAC Marianas Commander Captain Troy Brown, who nominated
13 Millie for the award, commended her exemplary lifetime service, embodying the
14 highest standards of dedication and commitment to the Department of Defense; and

15 **WHEREAS**, in addition to her remarkable career with the Department of
16 Defense, Millie has also served as a dedicated board member for the Community First
17 Federal Credit Union, where her extensive financial expertise has significantly
18 contributed to the success and growth of the institution. As a board member, Millie
19 played an instrumental role in overseeing the financial health and strategic direction of
20 the credit union, ensuring its services and operations met the needs of the island’s
21 community; her commitment to responsible governance, financial integrity, and service
22 to members has helped strengthen the financial stability and well-being of countless
23 families in Guam, enhancing their access to affordable and trusted banking services;
24 and her dedication to promoting financial literacy and inclusion on the island has earned
25 her deep respect from her peers and the wider community; and

26 **WHEREAS**, throughout her career, Millie has been known for her work ethic,
27 positive attitude, and her ability to inspire and mentor others. Her daily commitment to

1 excellence, coupled with her early morning workout routine and strong faith, has kept
2 her physically and mentally strong, enabling her to excel in both her personal and
3 professional life; and

4 **WHEREAS**, Millie is also an active member of her church, where her trust in
5 faith has helped her through both the challenges and triumphs of her career. She believes
6 that her success is a result of her strong spiritual foundation, and she credits her ability
7 to navigate the rocky waters of life to her unwavering trust in the Lord; and

8 **WHEREAS**, Millie's dedication to public service is also reflected in her family,
9 with one of her daughters, Karianne, following in her footsteps as a real estate officer
10 with NAVFAC Marianas. Millie's ability to balance her demanding career with her
11 commitment to family has earned her the love and admiration of her five (5) children,
12 six (6) grandchildren, and five (5) great-grandchildren, all of whom have supported her
13 throughout her remarkable career; now therefore, be it
