WHEREAS, it is the sense of *I Liheslaturan Guåhan* to recognize the life and accomplishments of those distinguished citizens of this great island, and it is custom of *I Liheslaturan Guåhan* to commend those public servants who have devoted themselves to faithfully serving in the best interests of this community and the needs of its residents; and
