BE IT RESOLVED BY THE COMMITTEE ON RULES OF I 1 2 MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN: 3 **WHEREAS,** Richard "Ric" Castro, a native Chamorro artist and Professor of 4 Art at the University of Guam since the 1990s, was born to Juan and Magdalena 5 L.G. Castro of Yigo, raised on his family's beach at Jinapsan, and deeply influenced 6 by his upbringing, family heritage, and Guam's natural environment; and 7 **WHEREAS**, Ric Castro holds an MFA and Four-Year Certificate in Painting 8 and Printmaking from the Pennsylvania Academy of the Fine Arts, as well as a BFA 9 from the University of Pennsylvania, and an Associate degree in Specialized 10 Technology in Visual Communication from the Art Institute of Pittsburgh. WHEREAS, Ric Castro has earned numerous awards, including a full 11 12 scholarship to the Pennsylvania Academy and the Ware Travel Award, which 13 enabled him to further his artistic growth and gain inspiration from Europe's rich 14 artistic heritage; and 15 WHEREAS, Ric Castro's artistic contributions encompass painting, 16 printmaking, and stone-carving. His work, which fuses Chamorro cultural themes

- 1 with contemporary artistic expression, has been showcased both locally and
- 2 internationally, with notable exhibitions in Japan, Tahiti, the Philippines, the
- 3 continental United States, and Guam. It is featured in private, corporate, and public
- 4 collections, as well as in prestigious galleries and exhibitions, including *Our Sea of*
- 5 Islands at the Hawai'i State Museum in Honolulu, where two of his paintings will
- 6 remain on display until December 2024; and
- WHEREAS, Castro's portfolio includes significant commissions such as a
- 8 40-foot mural for the Payless Store in Maite and artwork for institutions like the
- 9 Guam Congress Building, A.B. Won Pat International Airport, Pacific Islands Club
- 10 Hotel & Resort, Lotte Hotel, Louis Vuitton, Island Chiropractic Clinic, Taipei
- 11 Economic and Cultural Office in Guam, Japanese Consulate in Guam, DFS Galleria,
- and Pennsylvania Academy of the Fine Arts, among others; and
- WHEREAS, Castro's art reflects his Chamorro heritage, personal
- experiences, and the natural beauty of Guam, as seen in his celebrated series "Earth
- 15 Elements" and "Junglescapes of Guam," blending indigenous meanings with
- 16 abstract expressionism to capture the dynamic spirit of his culture and environment.
- 17 His impactful participation in the 13th Festival of Pacific Arts and Culture
- 18 (FESTPAC) in Hawai'i, showcased his unique artistic vision to the broader Pacific
- 19 community; and
- WHEREAS, Ric Castro's new exhibit, "Surface Portals & Liquid Koi
- 21 Dreams," at the CAHA Gallery marks his first solo exhibition in four years,
- 22 presenting a compelling collection of works that continue his exploration of form,
- color, and cultural identity; now therefore, be it
- 24 **RESOLVED,** that the Committee on Rules of *I Mina'trentai Siette Na*
- 25 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the
- people of Guam, recognize Richard "Ric" Castro on the opening of "Surface Portals
