





Senator Chris Barnett, Chairman - The Committee on Education, Public Safety and the Arts: Good morning Guam. Håfa Adai. Buenas, Manana si Yu'os. On this Thursday morning, this public hearing conducted by the Committee on Education, Public Safety, and the Arts is called to order at 8:10 CHamoru Standard Time. This morning, the committee is holding a public hearing to hear and accept testimony on the appointment of the following members of the Guam Council on the Arts and Humanities Agency Board of Directors, Monica Okada Guzman, to serve as member. Rolando Cepeda to serve as Visual Arts representative, and Simone Bollinger to serve as literature representative upon a conclusion of those appointments, we'll take a five-minute recess before we hear and accept testimony on Evangeline M. Cepeda to serve as member of the Guam Academy Charter Schools Council. Christine Baleto to serve as a private business representative in an upperlevel management position on the Guam Education Board of Directors, and Margarita Felicitas B. Angel as the retired teacher or school administrator of GDOE representative on the Guam Education Board of Directors. I'd like to welcome my colleagues joining us today, including my Vice Chair, Senator Chris Duenas and also Senator Tom Fisher. Before we begin, I'd like to go over the general rules of conduct. No pulling hair, biting, individuals testifying shall first be recognized by the chair before speaking and state their name for record keeping purposes. Questions and testimony shall be confined to the substance or nature of the agenda. Personal inference as to the character or motive of any senator or individual testifying is not permitted. We'll now proceed with discussions on the appointment of Ms. Monica Okada Guzman, to serve as member of the Guam Council on the Arts and Humanities Board of Directors. We'll begin with those present, here to present testimony on Ms. Okada Guzman's behalf before we hear from the appointee herself. So is there anyone here to testify on Monica's behalf? If not, then - Okay. Come on up. And ma'am, before you begin your testimony, please just state your name for the record.

**Chairman Barnett:** And we're back for our Chamorro 5 minute recess. This public hearing will now reconvene for the Committee on Education, Public Safety, and the Arts to hear and accept testimony on the appointment of Evangeline M. Cepeda to serve as member of the Guam Academy Charter Schools Council, are there any participants here to speak in favor or against this nomination? Please approach the table. And again, we're hearing the nomination of Evangeline M. Cepeda to the Guam Academy Charter Schools Council. Ma'am, if you don't mind just stating your name for the record and then proceed with your testimony.

Nadine Cepeda, District School Psychologist - Guam Department of Education: Absolutely. My name is Nadine Cepeda. Thank you, your honorable senator and chairperson Chris Barnett and the other senators that are here. My name is Nadine Cepeda. I'm a sibling of Evangeline Cepeda. I'm here in support of my sister to sit in for the

Academy Charter School Council for one of the charter schools. She has been serving for the last three years, but previously we talk about record. She's been committed and has been an ongoing public server, and is committed to this community. She has served in varieties of different boards as well as partaking in different roles in different capacities. Again, truly, she was elected years ago as a member of Guam Board of Education. And she continues to have the passion to try to make a difference. Our community does not have enough people who wanna serve. It's hard to be a public servant, not getting paid, but it's more about what can you give and how can you make a change as a therapist, as a district of school psychologist for the Department of Education and being in this field over 25 years and sitting in different boards, I must say it is something you have to balance. My sister has an empty nester. She isn't married and single. I say that because she can put all that time and energy to what needs to be done to make a difference in this community. So when I talk about someone characteristics, not everyone can be a true leader. She clearly has some traits and characteristics of leadership, and that's demonstrated through her work. One, she works with people. You cannot do it alone when you're a part of a council. Two, she's a mover and she makes a difference, not just rhetoric, not just criticizing. She is a solution. She finds solutions. And third or fourth it's about her commitment, compassion, and dedication. So if anything, I'm in support of her, not just because she's my sister, but she has a proven track record. And she's always served our Santa Barbara parish in different capacities and has a lot of passion and love to help people in our community, especially the youth. So thank you for this opportunity.

#### Chairman Barnett: Thank you ma'am. Christine?

**Christine Baleto:** Håfa Adai, once again senators, committee members. My name is Christine Baleto. I personally know Vangie Cepeda back from my time when I was in Sanctuary. It's amazing over the course of the history of my career that I've been fortunate enough to interact with many people. And Vangie Cepeda is one of them. She was at GHURA at the time, so I have come to ask for the confirmation of her to serve on the council based on my personal knowledge of her character and her work ethic. At the time that she was with GHURA and I was with Sanctuary, we worked very closely to get grants and support for the young children who were going through a difficult time. Many programs at Sanctuary were developed because of that collaboration. Her ability to work hard, drive towards a goal, and her passion for helping people have all been qualities that have made her successful. So, I didn't prepare anything more formal, but you know, again, I just want to express my support of Vangie to the council. Thank you.

Chairman Barnett: Thank you ma'am. Mr. Joe Sanchez.

Joe Sanchez, Deputy Superintendent of Curriculum Instruction - Guam Department of Education: Thank you. Good morning, Mr. Chair and Senators. My name is Joe Sanchez. I'm the Deputy Superintendent of Curriculum Instruction for the Guam Department of Education, and I'd like to offer my support for Ms. Vangie Cepeda for her appointment to the charter school board. I first met Ms. Vangie when she was a member of the Guam Education Board, and I was a starting administrator and I found her to be always a strong supporter of students and our teachers. She knew how to work well with our leadership and employees even through controversial circumstances. I remember specifically about pay raises and budget matters where she was never one to shy away from engaging with us. Charter schools are an important part of any comprehensive and healthy educational community. They are not in competition with public schools, but in fact a complement to our work. They allow for educators to explore new, innovative, sometimes controversial approaches to curriculum, instructional strategies and resources that may later be considered for others to implement upon their success. Ms. Vangie understands this, especially with her experience with the Guam Department of Education board, and is committed to supporting all charter schools while at the same time promoting the strengths on collaboration and relationships between charter schools and all other public schools. I humbly ask for your consideration of her reappointment. Thank you.

**Chairman Barnett:** Thank you, Mr. Sanchez. Is there any more testimony for or against Evangeline . Thank you so much for your testimony. Evangeline, if you could come up? And I know you have a prepared statement so you can proceed with that. Thank you, ma'am.

Evangeline M. Cepeda: Thank you. Håfa Adai, Good morning, Buenas. Senator Barnett, Senator Duenas, Senator Fisher, Senator Quinata, and the two women on this body. Thank you very much. Senator Joanne Brown and Senator Telo Taitague. My name is Evangeline M. Cepeda. And as you know, I just wanna thank the three. I didn't inform anybody about today. I just wanted to humbly come here, state my service that I, you know, I wanna thank Governor Lou Leon Guerrero and Lieutenant Governor Joshua Tenorio for believing in me and having me be reappointed to this. And with this body here, I ask for your confidence to just serve the Guam Academy Charter School Council. It's been four years. I'll correct my sister Nadine cuz she's the educated and the smart one in the family. But I've served for four years. On my first year of entering into the council I was elected by my peers of the council to be vice chair, totally clueless. I came on board and I said, okay, let's run with this. The following year, my council members believed in me and voted me to be chair. It's not what I've signed up for, but okay, I'm going to take it. I went and ran with it. And so my job is to work hard. I have nothing to benefit from this. My children are graduated. I'm just very passionate about helping and serving in this capacity. It's a thankless job and as Senator Barnett would know, I'm very passionate. He just got on board and I'm demanding to meet with him about the charter schools. You know, it's what I'm here to do. And I just like to say that with the charter schools, there's been positive stuff since we've been on board. And when I say we, I'm a team player. So the council, the board of trustees, all the way down to each of the four charter schools. We have a new charter school, ILearn. When we came on board, we've eliminated all prior year obligations. Every school had prior year obligations, sometimes going back three years. I got on the board and as a chair I said, no, we're not doing this. I'm not going to meet Senator Joe S. San Augustin again and Senator Telo Taitague and Senator Joanne Brown and have them ask me the same thing. We're going to pay out everything. Oh, now we only have SiFA that we have to work with and we're working on that. And then we have a new charter school come on board, Career Tech. Success story in itself. Started with seven. Everyone was asking seven, how are they going to survive? They've survived, they've grown. And it's a vocational school. It's like how VOtech used to be GCC, the old days where it's skill. It's very important because not everybody

wears the same size shoes. And in education we know this and many of them wanna go this direction and so there's a success on that. And hopefully, we'd, like the charter schools to grow. And so we're hoping to get two more charter schools on board within the next three, four years. And I think you know, this will cater to DOE because we know DOE is growing the capacity, it's overwhelming. The schools are break. It's the reality of everything. Not enough money. No matter how much money we have, there are problems that we need to fix. And charter schools, we have our own problems. I'm not gonna sit here before you and say this, but it's something that my goal is to resolve cuz I am about solution. Rhetoric, the same words, but I'm about finding solutions to these things. And hopefully while I'm here, because I always say I'm just preparing and fixing things up for the next person to come around. And so when I got on board, I was, it was clueless. We didn't have any record keeping, we didn't have anything. And so I'm proud to say before you, we do have that. And it's easier to come before this body and defend our justifications. With regards to each of the four charter schools that we have on board with each of them. They're growing. And as you know, I've reiterated this, that put a cap. The importance of putting a cap to each charter school is so we can emphasize on small. In the classroom, focus on each individual student and their strength and weaknesses, and then move them forward. That's the whole concept of keeping it capped. And I've firmly want to keep the cap and if they want to increase, open another charter school. So it just makes it better for every child to come into the schools and love where they're at, because environment is very important. And so when you have a very nice school, everybody's excited to learn. And so it's very positive. And so when everybody's positive, everybody's happy, and they're more everybody's learning. And so with that said, I just like to say if everyone you know, we've come before you before, I'm just asking for my confirmation for my reappointment to serve and serve the children and the charter school system. Thank you.

**Chairman Barnett:** Thank you. Thank you. Ms. Vangie. So what are your goals if you were reappointed?

Ms. Cepeda: My first goal is to basically keep everything accountable in the charter schools. And when, I mean that is from the council where we are at, to the board of trustees, to the schools and the administrators. We are doing that right now. But I think that there is a disconnect with the board of trustees. And don't get me wrong, senators, the board of trustees should be totally autonomized, should stay and remain that way. That is why there is certain success in the charter schools. But we're using the people's money, and as Joanne Brown has always said, Senator, the money has to be accountable. The money has to be accountable. So with that, I'd like to basically bring to you, on a round table very soon, to have the council at least twice a year, semi-annually, have a report justifying what the board of trustees are doing with the money. Because the board of trustees do day in, day out. They're the micromanager. They ensure that these schools are supposed, the charter schools, are supposed to do what they're supposed to do. We don't have that, that, as far as the law is concerned, I can't go in there and demand anything. I can ask for certain things that is required under the council, but I'm not gonna step on anybody's toes because I'm not in no purview or power to do so. So I'd like, like maybe semi-annually to have the board of trustees report to the council with regards and related to budget, funding. So it's easier for me when it's budget time that I come before you, that I am prepared and that I know

every dollar and what it's accounted for. I don't have that today. That's the first thing. The second thing is to have each charter school, each and every charter school give a justification with regards to their student. Because right now it's at 7.5. Okay. Bless you. Senator. 7.5 per student pupil. That already takes away from the DOE system, which they are at \$12 per student pupil. Okay. That is supposed to decrease the budget. Okay. If it doesn't, that's the whole process. That's the way it should be. I'd like to put a cap to each school. Right now there's a cap and I'm only saying that I can enforce that as a council chair, but it's nothing, a law that says, okay, there's a cap per charter school. So that's the second thing I'd like to implement. It's the cap to each charter school. And then the third, at least I like to do with the charter schools is I like each charter school, which we are kind of doing now, but I like it to be part of the law is that each charter school has a specific trait like, Guahan Academy, It's a DI program. You've got ILearn, which is a robotics. Okay. And then you've got SiFA, which is science and math. And then you've got Career Tech, which is more skilled and they emphasize on mathematics. These things I like them to bring to the floor. So we are fully aware of the success. They're not doing that. I like to enforce that. So when we come before this body, we can give success stories in black and white. And so these are the amazing things. I like to also bring up that all of them are accredited. Okay. So that's something to be proud of. Six years. And so you know this, that all of the charter schools are accredited, which is amazing. And they're performing at its best. So those are the three things I'd like to implement. If nominated today, I like to implement those immediately cuz I think that it would be a great advantage to the count, to the charter schools even after I leave. Cuz I'm just thinking that it would be something that we can move to make improvements cuz there's always room for improvements or you won't be here and I wouldn't be here. Yes.

**Chairman Barnett:** Thank you. Thank you, Evangeline. I wanted to just for, and I recognize my colleague, Senator Roy Quinata, good morning. I'd like to, if I could, just ask about the board of trustees. I know you had mentioned the law, but are there currently any obligations for the board of trustees to report to the council?

Ms. Cepeda: Nothing. Nothing whatsoever. And I understand that, let me go ahead and reiterate the board of trustees. There's so many bureaucracy in the government of Guam. It's just the way the government is. I like to keep the board of trustees their autonomy. Okay. That's not the concern. I want to keep that. That's what makes them the beauty of a charter school. If you look at the charter schools of California, any charter school, they have a board of trustees. They're independent. That's not what I'm saying. I'm saying that I'm, the only thing that I'd like for them by law is to have them do a semi-annual report to the council so we have an idea of what they're doing. They could be taking all this money on. When I came on board, when I came on board as a council, two schools were in a lawsuit. Okay? That was almost two years on a lawsuit. And senators, you know, this, I even met, I even asked to meet with their attorneys because I want this to be gone with and resolved. We did resolve it. It was ugly and it was too long. Part of that was because the board, the council was hadn't, was clueless. To what the board of trustees were doing. And all I'm saying is semi-annually, like, like anything else, do a report with regards maybe in August before the fiscal year and in January. And that's all they I'm requesting that the council get this maybe in August before the fiscal year of the Government of Guam and

January, so they can give us a report of their finances and what they've done with government funding.

Chairman Barnett: Thank you for that. Yeah,

Ms. Cepeda: You're very welcome. Thank you. Senator.

**Chairman Barnett:** I, if you could maybe just for those watching by the way, ate everyone watching on our legislature channel, Docomo, GTA and YouTube. But if you could explain the role of the board of trustees relative to the individual charter schools.

**Ms. Cepeda:** Sure. So the board of trustees in each different charter school, they have their board of trustees and they're basically, I'm gonna say they're very powerful. They have the power to the day in, day out operations and the money appropriated that is approved by the council. And it is drawn down by DOA. It's given to the schools that the administrators don't get it, the board of trustees receive this money, this funding, and they do as they please with the appropriation that's given, and the council has the power to get that appropriation. We sign, I sign it. And it goes to them. It's drawn down to them, and then they do within the parameters with whatever they need to do. And so the board of trustees in each of the schools are basically the micro, no, they micromanage it because they need, and they are part of the hiring, the firing. Okay. They are part of whatever necessary is to be done. That's the way it's done. So as I mentioned to you, Senator, when I came on board, \$128,000 was one board of trustees that won't mention names. But it's not done anymore.

Chairman Barnett: Oh, this is juicy. Pay attention to everybody. \$128,000 for?

**Ms. Cepeda:** Okay. \$128,000 was for their meeting. Having lunches, you know, extravagant lunches. When I became the chair, I was looking at this, what's this \$128,000, and it was going to that. Then I, at the time with Senator Telena Nelson as the chair. I said, Senator, we need to nip this. I need to re ensure that this is no longer happening. Put that money into the appropriation. I can disseminate it to the schools, which we have. We've done. So any lunches now is paid for by them. It's not paid for by the money appropriated by the council to the schools, to the charter schools. And so this is what, this is exactly what I'm mentioning here today.

**Chairman Barnett:** Thank you for that very insightful testimony. I wanted to ask ma'am, if you don't mind about the cap. So you're mentioning that you want to institute a cap for the charter schools?

Ms. Cepeda: Yes.

**Chairman Barnett:** But a lot of the charters that have come to see me since I got into office have actually asked for an increase in the number of students that they currently have as GDOE. And I know you said GDOE is growing, but Joe, correct me if I'm wrong, enrollment's actually down right? And yeah, enrollment is actually down.

**Ms. Cepeda:** So what I mean by growing, I mean as growing in as far as money, demand, needs, services. That's what I mean by growing. We're taking, you know, you've got the

private school, are taking some of those students. You've got charter schools and you've got many leaving the island, unfortunately. But for those that are entering to the charter schools with a cap, okay, we don't want to duplicate DOE, nothing bad, but we want to do, we want to keep it at charter school mentality and part of the charter schools is that it's not at 13,000 students as to oppose 350 per school. So I like to keep a cap on these things with regards to each of the four charter schools.

**Chairman Barnett:** Thank you. I'm gonna open it up to my colleagues for questions that we just met the other day. So I already exhausted my questions with you. Vice chair, Senator Duenas, Good morning.

Senator Christopher M. Duenas, Vice Chairperson - The Committee on Education, Public Safety and the Arts: Si Yu'os Ma'åse, Mr. Chairman and Ms. Cepeda. I got to say that, yeah, my first interaction with you when I was elected in the 36th was, of course we were traversing through Covid and then many of the meetings were still being done around that. And I know that there was a lot of accountability issues and I admire you. And then of course, former super, current acting superintendent, but a former speaker was also head of one of the charter schools, so I know that there was a lot of cleaning up that was going on. So I want to just express my thanks to you for being actively involved in that. I didn't know a lot of those things have worked themselves out. We'll see in this budget session, you know, where we're going with that. But yeah, so I'm a little interested as well. I like all the discussions about accountability. I know that myself also, I've met with a couple of the charter schools. They have discussed at least maintaining their cap. And then, but some have you know, asked to increase. But I think that this should be a fundamental discussion during the budget process. Cuz what I like that you're discussing on the report on a semiannual basis is the opportunity to, you know, to measure the success. I know that anecdotally, everybody that I meet, most of their children that are in charters, cause they're extremely excited and they're mentioning that, you know, their children are learning well, it's a good learning environment and the successes are there. I guess we'll do that through the budget process too. But I guess my only question to you would really be in terms of your tenure, what has been your most difficult over the last several years that you've been and like you said, you went from vice chair to chair and then what is one thing you definitely want to improve?

**Ms. Cepeda:** I like to improve, you know, I'm gonna say with the four charter schools, each of their personnel works cohesively with each other. The great thing about the charter school, I need to say, Senator Duenas, in regards to this is like if you go from Guahan Academy and you leave there and you go to ILearn, they work this out where ILearn goes into SiFA and then many of them go back to Guahan Academy to graduate or they now going choose to go to career tech. So there is a cohesive, working relationship with each of the four charter schools. What I'd like to see is, I'd like to see other, I would love to see two more charter schools come in and cater to liberal arts and cater to others because we have, already, we have like the math that they're emphasizing on robotics. I like to see others because some parents have expressed that their child is extremely good in math and they really wanna focus on that. We, you know, and unfortunately the schools are the only school that is a charter school that is from beginning to end is Guahan Academy, which is

DI instruction. And so I like to see other, maybe one or two other charter schools go into that direction. I think that would be really good for the charter schools. I think the day-today problems that we have, I think we can fix it, you know? And there's always room for improvement, but that's what I'd like to see going into my next few years if nominated today.

Vice Chairman Duenas: I think that's very insightful because I've heard that too. Right now it, the fluidity really is the flow and they can only go as high as where that level is and they need to articulate to the next charter school that would take them up through graduation. So I think you're on the right track. I mean, it sounds like it's gonna be more planning. And you know, of course, I think always got to do it in concert with DOE, but I'm sure they're happy too, you know, with the we've got to have this diversification. I mean, it's proven to work well and I know that at least I've come from a family of teachers. And I think maybe Joe can appreciate this, one of the things I think the charter schools have done is that you've got, like you said, nobody wears the same size shoes. You've got all kinds of different levels of individuals in schools that need different kind of training and experience. That's why DOE is so diverse. But these are focused, and I'm understanding most of the kids that are coming into these charter schools, they're prepared. They're ready to accelerate through the curriculum and the like, because, you know, their educational structure is very sound and very fundamental. I appreciate where you're going with that, and I think that's what we'll hear possibly in the presentation of the budget. And maybe that's part of the report that's due in terms of discussing the articulation through the system and refining it to where those kids can thrive all the way through moving into higher education afterwards. I appreciate your energy and I also appreciate the fact that I've seen you at the round tables and the others. I mean, you've taken an initiative to interject even though you're not particularly on the hot seat. And so I wanted to say thank you for that advocacy. It certainly bodes well for your nomination. So thank you. That's all I have. Mr. Chairman.

Chairman Barnett: Thank you, Vice. Senator Taitague.

**Senator Telo T. Taitague:** Thank you, Mr. Chair. My colleagues know that I'm not one to come out very much and say straight out, I support your nomination.

Ms. Cepeda: Thank you, Senator.

**Senator Taitague:** Yeah it's rare I do that. But for you, Vangie you know, I've seen the work you've done. You're amazing, your energy, you're constantly on top of things. I'm just so happy to see that you want to continue to serve.

Ms. Cepeda: Thank you, Senator.

**Senator Taitague:** So you have my full support. You're, you have an amazing family as well, and it's so impressive that you not only have the private sector, you had the, you know, public sector and then of course you had a family member here testifying in your favor. You've covered all angles and that's something I've always expected from you. Yeah.

Always bringing your A game. Thank you. And I greatly appreciate. The only thing I have to say is please, you know, you really do so much. You give 120%. So I hope that you take a little bit of that percentage and take time for yourself. Don't burn out because I definitely don't wanna see you having to, you know, leave your position because right now the charter schools are growing and you're the perfect person to watch it grow in the right direction. So thank you so much and thank you to your family. And of course my door is always open as you know that I've got calls from you, so, and you will get calls from me. Thank you so much. Thank you, Mr. Chair.

**Chairman Barnett:** Van, you better note this down. Yes, you're right. I've never heard her say I, I fully support right off the bat. Maybe after about 10 hard questions, but that was definitely a first. So thank you Senator Taitague, Senator Brown.

Senator Joanne M. Brown, Member - The Committee on Education, Public Safety and the Arts: Thank you very much. Mr. Chair and Evangeline, I have to tell you know, your presentation and your energy is very refreshing. You don't see that a lot in government, unfortunately. And, you know, you keep us from getting jaded cuz it's so easy to do that, especially with education because you know, having been around long enough, you just see the repeated problems and we pour more money into it and the problems don't change. They sometimes get worse. And, you know, the opportunity to encourage our children to enjoy education and prosper and grow is important. And we miss that time. This critical time in their growth process. I mean, that affects everything in their life. All we hear more is the drug problem and graduating to DOC and the, it doesn't show the best side of our society and our community and everything that we grew up with and want, certainly for our children and grandchildren to have and experience. And I appreciate the work that you do. I ultimately, when we supported creating the charter schools was the idea eventually to hope to phase out DOE. And I don't mean that in a negative way. I want to ensure that our public funds are going and being invested, you know, to help these children. Cuz many of them don't get, as we know, sad to say, a lot of our children don't get that support in a family environment anymore. I mean, you know, like I said, we used to be able to, if we got in trouble, our parents knew about it before we got home, before these things existed. And a lot, and many of our young people are not even growing up with that. I mean, when you hear, and it's heartbreaking to hear, as we heard during the pandemic, there are children that don't even eat. And the fact that could happen in our community is just very disturbing because you're like, oh my God, really with all that we have children in our community because whatever the situation with their family don't even eat a meal because they don't come to school. And I think we want to improve on that and by all means we have an obligation to do so. I certainly support what you do. I hope you keep DOE on their toes because you could do better for less. And I think that puts the bar up for them the expectation of better performance because they do get paid more. My son goes to private school and his teachers, I'm very impressed with them as well. And they don't get paid anywhere near and they're not there obviously for the money. Cuz if they were, they could take their credentials and go and teach in the public school system. But it's the community that is created and the environment that these children are growing up in that makes such a difference. It provides that support for them. That makes 'em wanna go to school and spend time and be with their classmates and do all these exciting things. And it

makes such a difference cuz we had that opportunity and that's what hopefully has gotten us to where we're at. I mean, you're a Notre Dame grad, you're only a year behind me, so you've probably crossed paths in the last 42, 43 years. It's been that long. But I wish you I wanna see more of what you do and see the continued improvement and growth in our charter schools. More importantly, the accountability in our charter schools. Cuz I, I'm concerned as time goes on and as our chairman continues to pursue the issues with our public education, you know, we're gonna see a lot more problems coming. And that's disturbing because at some point you think if we've done it long enough, we should be good at it and we're not there. Yeah. You know, we're not there yet. So you certainly also have my support and I wish you continued success and I appreciate the continued engagement and the energy and the drive and the commitment, cuz that's something you can't give somebody. You know, you can try and pose it on someone, but you can't make it happen. That has to come from within. And you're certainly brought a lot of bright energy to our hearing this morning, my dear. So, continued success to you. I mean, we need good people like we really do because the impact you will have and have had on our children out there, you know, they may not realize it, but you're helping pave the way of a very good and promising future for them. And that's what we wanna see for all our kids. Congratulations in advance on your vote and reconfirmation, and thank you again for your service. Thank you, Mr. Chairman.

Chairman Barnett: Thank you, Senator Brown. Senator Quinata.

**Senator Roy A.B. Quinata:** Congratulations. Good morning. Mrs. Cepeda. I don't think we have much questions or issues with you. I think you're more like a mama bear to the charter school. You wanna see more transparent activities. You wanna make sure that the children are being educated and having a full fully vetted education system. So, you know, with that being said I wish you all the best and let us know what we can do to help you and aid of all of your future endeavors. I'm sure your oversight chair of education is right behind you. He likes juicy things, so, you know, we're here to support you in any way we can. Okay. Have a great day, and God bless.

**Chairman Barnett:** Thank you very much. Senator Quinata, definitely love the juicy things. We're good. I think we're good. We're good? We're good. Okay. So, Evangeline, we consider your appointment duly heard, and we look forward to voting on your nomination on the floor.

Ms. Cepeda: Thank you Senators for being present. Appreciate it. Thank you.

**Chairman Barnett:** And if there's no more testimony to be heard committee on Education, Public Safety and the Arts will continue to accept testimony on all of the appointments we heard this morning.
