**AN ACT TO AUTHORIZE THE EXTENSION OF THE GAS
TAX RELIEF ACT FOR ANOTHER ONE HUNDRED EIGHTY
(180) CALENDAR DAYS.**

BE IT ENACTED BY THE PEOPLE OF GUAM.

Section 1. Authorization to extend the *Gas Tax Relief Act*. All levy of excise taxes, automotive surcharges, and mass transit automotive surcharges on Liquid Fuel *shall* be temporarily waived for another one hundred eighty **(180)** calendar days.

Section 2. Effective Date. This Act *shall* be effective upon enactment.

Section 3. Severability. If any provisions of this Act or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity shall not affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
