AN ACT TO AUTHORIZE THE EXTENSION OF THE GAS TAX RELIEF ACT FOR ANOTHER ONE HUNDRED EIGHTY (180) CALENDAR DAYS.

### 1 BE IT ENACTED BY THE PEOPLE OF GUAM.

- 2 **Section 1. Authorization to extend the** *Gas Tax Relief Act.* All levy of excise
- 3 taxes, automotive surcharges, and mass transit automotive surcharges on Liquid Fuel
- 4 *shall* be temporarily waived for another one hundred eighty (**180**) calendar days.
- 5 **Section 2. Effective Date.** This Act *shall* be effective upon enactment.
- 6 Section 3. Severability. If any provisions of this Act or its application to any
- person or circumstance is found to be invalid or contrary to law, such invalidity shall
- 8 not affect other provisions or applications of this Act that can be given effect without
- 9 the invalid provision or application, and to this end the provisions of this Act are
- 10 severable.
