**AN ACT TO EXTEND THE FISCAL YEAR ~~[2022-]2023~~
GOVERNMENT OF GUAM GROUP HEALTH INSURANCE
PLAN DOA/HRD/EB-RFP-GHI-23-001 TO ~~[SEPTEMBER 30, 2024]~~
DECEMBER 31, 2023.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Intent.** It is the intent of *I Liheslatura* to extend and
3 rollover the current fiscal year ~~[2022-]2023~~ Government of Guam Group Health
4 Plan DOA/HRD/EB-RFP-GHI-23-001 (“Group Plan”) ~~[as of September 30, 2024]~~
5 to December 31, 2023.

6 **Section 2. Fiscal Year 2023 Group Health Plan Extension.**
7 Notwithstanding any other provision of law, the fiscal year ~~[2022-]2023~~
8 Government of Guam Group Health Plan DOA/HRD/EB-RFP-GHI-23-001 is
9 extended to ~~[September 30, 2024]~~ December 31, 2023.

10 All payment terms, promises, requirements, conditions, provisions, and
11 representations contained and specified in the Government of Guam Group Health
12 Plan *shall* remain the same, survive, and continue under the Act until ~~[September~~
13 ~~30, 2024]~~ December 31, 2023.

1 **Section 3. Reserve Fund Surcharge.** Each premium amount charged in
2 Fiscal Year 2023, that is extended by this Act for the period of October 1, 2023
3 through December 31, 2023, shall have *added* to it a seven percent (7%) increase.
4 This increase shall be a “*Reserve Fund Surcharge*” and shall be collected and
5 deposited into the Trust Accounts for either Medical and Pharmacy or Dental.

6 **Section 4. Self-Funded Health Insurance Program.** Beginning January 1,
7 2024, the Exclusive Options selected by *I Maga Hagan Guahan*, as evidenced by
8 her August 3, 2023 Memorandum of Approval, of SelectCare as the Third-Party
9 Administrator for Medical and Pharmacy, and NetCare as the Third-Party
10 Administrator for Dental shall be recognized by *I Liheslaturan Guahan* in the same
11 manner as a bid award and gives it the same force and effect as a contractual
12 obligation.

13 **Section 5. Open Enrollment.** The Department of Administration shall
14 coordinate an Open Enrollment period of no less than three (3) weeks prior to
15 January 1, 2024 that provides multiple opportunities for government of Guam
16 Subscribers and their Dependents to learn of the differences in plan design and
17 provider networks for the Self-Funded Health Insurance Program when compared to
18 the extended Fiscal Year 2023 Government of Guam Group Health Insurance
19 Program. The Department of Administration shall publish and make available a Self-
20 Funded Health Insurance Program rate sheet that lists the employer and employee
21 premiums for all plans offered. This rate sheet shall be available on or before October
22 31, 2023.

23 **Section 6. Provider Orientation.** Each Third-Party Administrator
24 identified in Section 4 shall conduct provider orientations outlining any changes to
25 be expected in the Self-Funded Health Insurance Program as compared to the
26 extended Fiscal Year 2023 Government of Guam Group Health Insurance Program.
27 This orientation shall take place prior to January 1, 2024.

1 **Section 7. Effective Date.** Unless indicated otherwise, the effective date for
2 this Act shall be upon enactment.
