AN ACT RELATIVE TO TRANSFER OF THE TITLE OF OWNERSHIP OF LOT NO. 7 NEW, BLOCK NO. 1, TRACT 1427 LOCATED IN THE MUNICIPALITIES OF TAMUNING, TIYAN FROM THE GUAM INTERNATIONAL AIRPORT AUTHORITY TO THE CHAMORRO LAND TRUST COMMISSION.

## BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Findings and Intent. *I Liheslatura* finds that Lot No. 7
- 3 NEW, Block No. 1, Tract 1427, was transferred to the Guam International Airport
- 4 Authority (Airport) by the government of Guam for the development of industrial
- 5 operations directly related to airport operations.
- After the transfer of this government property to the Airport, all lands not
- 7 reserved for specific purposes were subsequently transferred to the Chamorro Land
- 8 Trust (Trust) for its use in meeting the Trust's mandate and obligations to it
- 9 beneficiaries.

- 10 I Liheslatura finds that this Lot No. 7 NEW, Block No. 1, Tract 1427, had it
- 11 not been transferred to the Airport for the specific purpose of industrial
- development as part of the Airport Industrial Park it would have been subsequently
- transferred to the Trust for its use.

*I Liheslatura* finds that the operation and commission of a lease to a restaurant facility for which the Airport does not have any direct relation to its operations and thus is not needed by the Airport to meet its mandate.

Therefore, *I Liheslatura* intends to transfer the property and lease of the restaurant facility from the Airport whose services are not directly related to its operations to the Trust, in order to support the development of basic infrastructure of the Trust properties to make them habitable.

Section 2. Transfer of Title. Title to and jurisdiction over the parcel of real property Lot No. NEW, Block No. 1, Tract 1427 containing an area of 4,091 ± square meters presently under lease for the operations of a restaurant facility is hereby transferred from the Guam International Airport Authority to the Chamorro Land Trust Commission which *shall* act as sole administrator of the lease to this parcel and shall receive all payments thereunder. All other terms of the lease agreement executed prior to January 17, 2011 (the "Lease") between the lessee and the Airport shall remain in effect, except that references to the Guam International Airport Authority *shall* be deemed to refer to the Chamorro Land Trust Commission.

Section 3. Effective Date. This Act shall take effect upon enactment.

**Section 4. Severability.** If any provision of this Law or its application to any person or circumstances is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this Law which can be given effect without the invalid provisions or application and to this end the provisions of this Act are severable.
