AN ACT TO APPROPRIATE UNEXPENDED FUNDS  
ESCHEATED TO THE GENERAL FUND, PURSUANT  
TO §21116 OF CHAPTER 21, DIVISION 2, TITLE 5,  
GUAM CODE ANNOTATED, FOR THE PURPOSE OF  
FUNDING PRINCIPAL AND INTEREST  
OBLIGATIONS PURSUANT TO THE GUAM  
FEDERATION OF TEACHERS V. GOVERNMENT OF  
GUAM, ET. AL., SUPERIOR COURT CASE NO. SP  
0009-07.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2       **Section 1. Appropriation.** Notwithstanding any other provision of  
3 law, unexpended funds escheated to the General Fund at the end of Fiscal  
4 Year 2012 and are available for appropriation in Fiscal Year 2013, pursuant  
5 to §21116 of Chapter 21, Division 2, Title 5, Guam Code Annotated, are  
6 hereby appropriated to the Department Education for the purpose of  
7 paying principal and interest obligations pursuant to the Guam Federation

1 of Teachers v. Government of Guam, et. al., Superior Court Case No. SP  
2 0009-07, in accordance with P.L. 31-233, Chapter I, Section 5.

3 **Section 2. Unused Appropriations; Excess Funds.** Funds not  
4 expended pursuant to Section 1 of this Act, within one (1) year following  
5 the date of enactment, shall no longer be available to the Department of  
6 Education. Such funds shall be available for future appropriations by *I*  
7 *Lihselaturan Guåhan*.

8 In the event there are excess escheated funds available following the  
9 satisfaction of principal and interest obligations, in accordance with Section  
10 1 of this Act, such funds shall be available for future appropriations by *I*  
11 *Lihselaturan Guåhan*.

12 **Section 3. Reporting Requirement.** The Superintendent of  
13 Education and the Director of the Department of Administration, shall each  
14 submit a report to *I Maga'låhen Guåhan* and *I Lihselaturan Guåhan*, no later  
15 than One Hundred Eighty (180) days following enactment of this Act,  
16 detailing all transactions pertaining to funds appropriated herein.

17 **Section 4. Effective Date.** This Act shall be effective upon  
18 enactment.
