

This proposed bill is advocating the suspension of all tax credits except as authorized prospectively upon the enactment of this bill, as contractually obligated or authorized under the Internal Revenue Code. Section 3 of this bill authorizes the repeal of all tax credits statutes provided such repeal do not impact contractual obligations made prior to the enactment of this proposed bill. 

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 **Section 1. Short Title.** This Act shall be cited as the "Responsible
3 Tax Credit Suspension Act."

4 **Section 2. Tax Credit Suspension.** Notwithstanding any other
5 provision of law to the contrary, the government of Guam shall not issue
6 any tax credits upon the enactment of this Act, except as authorized by
7 statute duly adopted prospective to this Act, as contractually obligated
8 prior to the enactment of this Act, or as authorized under the Internal
9 Revenue Code.

10 **Section 3. Repeal of Tax Credit Provisions.** Notwithstanding any
11 other provision of law to the contrary, all tax credits authorized under local
12 law shall be repealed upon the enactment of this Act, except that the repeal
13 of any statute shall not affect any contractual obligation entered into prior

1 to the enactment of this Act or any tax credits authorized under the
2 Internal Revenue Code. Upon the enactment of this Act, the Compiler of
3 Laws shall amend all provisions of law relative to tax credits to accomplish
4 the repeal of all tax credits authorized under local law.
