AN ACT ADD A NEW §1106(a) TO 2 GCA AND AMEND §40109(a) OF 5 GCA; RELATIVE TO AFFECTING ELECTED AND APPOINTED OFFICIAL COMPENSATION.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Short Title.** This Act *shall* be cited as the “Public Official
3 Compensation Reduction Act of 2015.”

4 **Section 2. Restore Salaries to Levels Before Public Law 27-05.**

5 Notwithstanding any other provision of law, statutes, executive orders, regulations,
6 or compensation plans to the contrary, all laws, statutes, compensation plans, and
7 compensation rates of elected and appointed officials whose compensation was
8 affected by the enactment of Public Law 32-208, except as provided in Section 4 of
9 this Act, are hereby reenacted to the language and amounts that existed prior to the
10 enactment of Public Law 32-208

11 **Section 3. Legislative Compensation.** Notwithstanding any other
12 provision of law, a new Subsection (a) is hereby added to 1106 of Chapter 1, Title
13 2, Guam Code Annotated, to read:

14 “(a) Compensation of each member of *I Liheslaturan Guåhan* shall be
15 paid in twenty-six (26) equal installments at the rate per annum of Fifty-Five
16 Thousand Three Hundred Seven Dollars (\$55,307.00); the compensation of

1 the Speaker of *I Liheslaturan Guåhan* shall be paid in twenty-six (26) equal
2 installments at the rate per annum of Sixty Thousand Eight Hundred Thirty-
3 Seven Dollars (\$60,837.00). Such compensation shall be paid out of funds to
4 be appropriated to *I Liheslaturan Guåhan*.”

5 **Section 4. Mayor and Vice Mayor Salary.** Subsection (a) of §40109,
6 Chapter 40, Title 5, Guam Code Annotated, is hereby amended, to read:

7 “(a) Notwithstanding any other provision of law to the contrary, the
8 salary for a Mayor shall be Forty-Six Thousand Sixty-Two Dollars
9 (\$46,062) per annum; and the salary for a Vice mayor shall be Forty-Two
10 Thousand Two Hundred Sixty-Four Dollars (\$42,264) per annum. ~~The~~
11 ~~compensation of the Chief Mayor, Mayors and Vice Mayors shall be that~~
12 ~~provided in 4 GCA § 6206.~~”

13 **Section 5. Governor and Lieutenant Governor Retirement Annuities.**
14 Notwithstanding any other provision of law to the contrary, the retirement
15 annuities of a Governor or Lieutenant Governor and their survivors, provided
16 under 4 GCA §8172, for a Governor or Lieutenant Governor who was in office
17 between the enactment of Section 8 of Chapter IV of Public Law 27-5 and the
18 effective date of Section 3 of this Act shall not be affected by any increase in
19 annual salary during such period.

20 **Section 6. Severability.** *If* a provision of this act or its application to any
21 person or circumstance *is* held invalid, the invalidity does not affect other
22 provisions or applications of the act that can be given effect without the invalid
23 provision or application, and to this end the provisions of this act are severable.
