**AN ACT TO REPEAL AND REENACT § 3108 AND TO AMEND § 3202,
BOTH OF CHAPTER 3, TITLE 19, GUAM CODE ANNOTATED,
RELATIVE TO NAMES ON MARRIAGE LICENSES.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guáhan* finds that there is a need to update Guam statute regarding the choices of name upon marriage. It is the intent of *I Liheslaturan Guáhan* to allow a spouse greater options relative to his or her choice of a middle name and a surname, or a surname alone, upon marriage by indicating such election on a marriage license application.

Section 2. § 3108 of Chapter 3, Title 19, Guam Code Annotated is hereby *repealed* and *re-enacted* to read:

~~“§3108. Choices of Name Upon Marriage.~~

~~Upon entering into a contract of marriage a spouse may elect to retain his or her surname before marriage as his or her surname upon marriage. Upon entering into a contract of marriage, either spouse may elect to hyphenate his or her surname with the surname of the other spouse. Intention of the exercise of said election shall be indicated upon the marriage license application as provided for by § 3202 of this Title.~~

1 **§ 3108. Choices of Name Upon Marriage.**

2 (a) Upon entering into a contract of marriage, a spouse may elect to
3 retain his or her surname before marriage as his or her surname after
4 marriage, or a spouse may elect to adopt any of the following
5 surnames:

- 6 (1) The current surname of the other spouse;
- 7 (2) The surname of either spouse given at birth;
- 8 (3) A combination of surnames; or
- 9 (4) Either spouse may elect to hyphenate his or her surname with
10 the surname of the other spouse.

11 (b) Upon entering into a contract of marriage a spouse may elect to retain
12 his or her middle name before marriage as his or her middle name
13 after marriage, or a spouse may elect to adopt any of the following
14 middle names:

- 15 (1) The current surname of either spouse.
- 16 (2) The surname of either spouse given at birth.
- 17 (3) A combination of the spouse's current middle name, and the
18 current surname of the other spouse; or
- 19 (4) A combination of the spouse's current middle name and
20 surname.
- 21 (5) A combination of the spouse's current middle name and
22 spouse's surname given at birth; or
- 23 (6) A combination of the spouse's current middle name, and the
24 other spouse's surname given at birth.

25 (c) An election by a person to change his or her name pursuant to this
26 Section shall serve as a record of the name change. A certified copy
27 of a marriage certificate indicating a person's new name, or retaining

1 the former name, shall constitute proof that the use of the new name
2 or retention of the former name is lawful.”

3 **Section 3.** § 3202(a) of Chapter 3, Title 19, Guam Code Annotated, is hereby
4 *amended* to read:

5 “§ 3202. **Marriage Licenses.**

6 (a) All persons about to be joined in marriage must first obtain a license
7 therefore, from the Department of Public Health and Social Services,
8 which license shall state:

9 (1) The identity of the parties;

10 (2) Their full names, residence, and place of birth;

11 (3) Their date of birth;

12 (4) Their citizenship;

13 (5) If an alien, whether a resident alien or a non-immigrant alien;

14 (6) The number of previous marriages, wherever contracted and how
15 terminated; the occupations of the parties, the surname of ~~the female~~
16 each, if previously married; the names and birthplaces of each; and
17 the maiden name of the mother of each;

18 (7) Whether a spouse elects to retain his or her surname ~~before marriage~~
19 ~~as his or her surname upon marriage~~ as provided for by § 3108; ~~;~~

20 (8) Whether either party elects to hyphenate or change his or her
21 surname ~~with the surname of the other party upon marriage~~ as
22 provided for by § 3108; ~~;~~

23 (9) Whether either party elects to retain or change his or her middle
24 name upon marriage as provided for by § 3108;

25 ~~(9)~~ (10) Social Security Number of Each Party. If a party does not have
26 a social security number, he must state that fact; ~~;~~ and

1 ~~(10)~~(11) Whether the applicants elect to have their marriage
2 solemnized by a village mayor or vice mayor.

3 **Section 4. Effective date.** This Act *shall* take effect 180 days after enactment.
