**AN ACT TO APPROPRIATE THE SUM OF ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000) FROM THE GENERAL FUND, FROM THE PROCEEDS COLLECTED THROUGH THE TAX AMNESTY PROGRAM, FOR THE SOLE PURPOSE OF THE PROCUREMENT OF AN OWNER'S AGENT ENGINEER (OAE), ARCHITECTURAL AND ENGINEERING (A&E) SERVICES, AND OTHER RELATED SERVICES PURSUANT TO § 58D105 OF CHAPTER 58D, TITLE 5, GUAM CODE ANNOTATED, FOR THE CONSTRUCTION OF A NEW SIMON SANCHEZ HIGH SCHOOL.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation to the Guam Department of Education for the**  
3 **OAE, A&E and other related Services for the construction of a new Simon**  
4 **Sanchez High School.**

5 The sum of One Million Five Hundred Thousand Dollars (\$1,500,000)  
6 is hereby appropriated from the Fiscal Year 2018 General Fund (from the proceeds  
7 collected through the Tax Amnesty Program) to the Guam Department of Education  
8 (GDOE) for the *sole* purpose of the procurement of an Owner's Agent Engineer  
9 (OAE), architectural and engineering (A&E) services, and other related services  
10 pursuant to §§ 52101 and 52102 of Chapter 52, Division 2, Title 11, Guam Code  
11 Annotated, for the construction of a new Simon Sanchez High School.

1           **Section 2. Restriction on the Use of Funds.**

2           Such funds appropriated to GDOE in this Act *shall not* be transferred,  
3 used, or expended for any other purposes other than what is specified in this Act.

4           **Section 3. Reporting Requirement.** Within 60 days of the end of Fiscal Year  
5 2018, the Superintendent of Education or his designee shall report to *I Maga'låhen*  
6 *Guåhan* and the Speaker of *I Liheslaturan Guåhan* on the status of the utilization of  
7 funds made available in this Act for the construction of a new Simon Sanchez High  
8 School, and shall subsequently provide a status report every 90 days thereafter until  
9 such funds are fully expended.
