Section 3. Reporting Requirement. Within 60 days of the end of Fiscal Year 2018, the Superintendent of Education or his designee shall report to *I Maga'låhen Guåhan* and the Speaker of *I Liheslaturan Guåhan* on the status of the utilization of funds made available in this Act for the construction of a new Simon Sanchez High School, and shall subsequently provide a status report every 90 days thereafter until such funds are fully expended.
