AN ACT RELATIVE TO **EXEMPTING** APPLICATION OF § 5127 OF SUBARTICLE C, ARTICLE 2, CHAPTER 5, TITLE 5, GUAM CODE ANNOTATED, **FROM** THE **ADMINISTRATIVE** JURISDICTION GRANTED TO THE OFFICE OF THE MAYOR OF TALOFOFO AND THE MUNICIPAL PLANNING COUNCIL OF TALOFOFO FOR THE USE OF LOT NO. 1. BLOCK 14. **TRACT** 2831. **MUNICIPALITY OF** TALOFOFO, **FOR** THE PURPOSE OF CONSTRUCTING A RECREATIONAL SPORTS FACILITY, AND AUTHORIZING OFFICE OF THE MAYOR OF TALOFOFO AND THE MUNICIPAL PLANNING COUNCIL OF TALOFOFO TO **INTO ENTER MEMORANDUM** A **AGREEMENT** WITH THE **GUAM FOOTBALL** (SOCCER) ASSOCIATION FOR THE USE OF SAID REAL PROPERTY FOR A TERM NOT TO EXCEED THIRTY (30) YEARS.

## BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that the Guam Football (Soccer) Association ("Association") many years ago established a 3 partnership with the government of Guam for the access and use of government property 4 in Dededo, which the Association developed into a world class and internationally 5 recognized soccer sports complex. This sports complex has served thousands of soccer 6 7 enthusiasts, in particular hundreds of children, over the years in the development of 8 their skills, which has contributed to Guam's increased competitiveness in the sport nationally and internationally. I Liheslaturan Guåhan further finds that the Association 9

- 1 has expressed interest in developing a comparable sports complex through a similar
- 2 arrangement with the use of a previously designated property, which was identified
- 3 within Public Law No. 34-60 and which is now under the administrative jurisdiction of
- 4 the Office of the Mayor of *Talofofo* and the Municipal Planning Council of *Talofofo*.
- 5 Therefore, it is the intent of I Liheslaturan Guåhan to grant the Office of the Mayor of
- 6 Talofofo and the Municipal Planning Council of Talofofo the authorization to enter into
- 7 an arrangement for the use of the aforementioned property with the Association.
- 8 Section 2. Authorization for the use of real property within the 9 administrative jurisdiction of the Office of the Mayor of Talofofo and the 10 Municipal Planning Council of Talofofo for the construction and operation of a recreational sports complex for a timeframe not to exceed thirty (30) years. 11 In 12 accordance with the provisions contained in Public Law No. 34-60, the Office of the Mayor of Talofofo and the Municipal Planning Council of Talofofo are hereby 13 14 authorized to enter into a Memorandum of Agreement with the Guam Football (Soccer) 15 Association for the use of that real property described as Lot 1, Block 14, Tract 2831 in the Municipality of Talofofo, Guam, consisting of 31,026 square meters (7.7 acres) as 16 17 shown on DLM Map No. 069FY91. The timeframe set forth in the Memorandum of Agreement shall be exempt from the application of § 5127 of SubArticle C, Article 2, 18 19 Chapter 5, Title 5, Guam Code Annotated, and shall be for a term not to exceed thirty (30) years. The aforementioned real property shall be utilized for the purpose of 20 21 constructing a recreational sports facility, which shall include the development of 22 soccer fields and related facilities.
  - Section 3. Effective Date. This Act shall be effective upon enactment.
