1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

3 **Section 1. Legislative Intent.** Public Law No. 33-18 authorized a pay dif-
4 ferential for the positions of Certified Public Accountant, Certified Government
5 Financial Manager, Certified Fraud Examiner, and Certified Internal Auditor for
6 those persons employed in these positions who obtained the certifications. This
7 public law was further amended by Public Law No. 33-222 to clarify the number
8 of pay certifications allowed for those qualifying employees.

9 It has come to the attention of *I Liheslatura* that persons employed as faculty
10 or administrators under the pay scale of the University of Guam, as approved by
11 the UOG Board of Regents, are being interpreted to be inadvertently omitted from

1 this pay differential. This legislation is designed to include those employed under
2 the UOG pay scale who otherwise qualify for the certification differential pay.

3 **Section 2. Inclusion of Personnel employed as Faculty or Administrators**
4 **under the University of Guam Pay Scale Approved by the UOG Board of Re-**
5 **gents in the Pay Differential Authorized by § 6235 of Title 4, Guam Code An-**
6 **notated.** § 6235 (d)(4) of Title 4, Guam Code Annotated, is amended to read:

7 “§6235 (d)(4). Except for faculty and administrators of the University of
8 Guam, ~~T~~the employee salary must be commensurate with the currently approved
9 government of Guam pay/wage scale. The salary for University of Guam faculty
10 and administrators must be commensurate with the currently approved Board of
11 Regents pay/wage scale. Any deviation from the currently approved government of
12 Guam pay plan, or from the UOG Board of Regents approved pay plan for UOG
13 faculty and administrators, shall not qualify for the differential pursuant to this
14 Subsection (d).”

15 **Section 3. Effective date.** The provisions of this legislation shall be effec-
16 tive on the date of enactment.
