AN ACT TO AMEND SECTION 1 OF PUBLIC LAW 32-208 RELATIVE TO EXCLUDING *I MAGA'LÁHAN GUÁHAN*, *I SEGUNDU NA MAGA'LÁHEN GUÁHAN*, AND SENATORS OF *I LIHESLATURAN GUÁHAN* FROM THE COMPETITIVE WAGE ACT OF 2014; AND TO ADD A NEW § 1106.1 TO CHAPTER 1, TITLE 2, GUAM CODE ANNOTATED; TO ADD § 1103 TO DIVISION 1 OF ARTICLE 1 OF CHAPTER 1, TITLE 5, GUAM CODE ANNOTATED; TO ADD § 2100.1 TO ARTICLE 1 OF CHAPTER 2, TITLE 5, GUAM CODE ANNOTATED RELATIVE TO REDUCING THE COMPENSATION OF *I MAGA'LÁHAN GUÁHAN*, *I SEGUNDU NA MAGA'LÁHEN GUÁHAN*, AND SENATORS OF *I LIHESLATURAN GUÁHAN*.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 **Section 1.** Section 1 of Public Law 32-208 is hereby *amended* to read:

3 “**Section 1.** Notwithstanding any other provision of law, rule,
4 regulation, policy, or procedure, the salaries of ~~*I Maga'láhen Guáhan*, *I*~~
5 ~~*Segundu na Maga'láhen Guáhan*, *Senators of I Liheslaturan Guáhan*~~, and the
6 Attorney General of Guam, shall be set to the respective salary rates pursuant
7 to the Competitive Wage Act of 2014, which was transmitted and received by
8 *I Liheslaturan Guáhan* on January 15, 2014. The appropriations from FY
9 2015 are hereby authorized for the payment of the salaries for ~~of~~ the positions
10 identified in this Section. The salaries of the Public Auditor of Guam and

1 staff of the Office of Public Accountability shall be set pursuant to § 1907 of
2 Chapter 19 of Title 1, Guam Code Annotated. Nothing in this section shall
3 repeal or negate the provisions contained in Public Law 32-166.”

4 **Section 2.** A new § 1106.1 is *added* to Division 1 of Article 1 of Chapter 1,
5 Title 5, Guam Code Annotated, to read:

6 “§ 1106.1. **Senatorial Salaries.** Notwithstanding any other provision
7 of law, rule, regulation, policy, or procedure, compensation of each member of *I*
8 *Liheslaturan Guåhan* [the Guam Legislature] shall be paid at the rate of Fifty-Five
9 Thousand Three Hundred Three Dollars (\$55,303) per annum; the compensation of
10 the Speaker of *I Liheslaturan Guåhan* shall be paid Sixty Thousand Eight Hundred
11 Fifty Dollars (\$60,850) per annum. Such compensation shall be paid out of funds to
12 be appropriated to *I Liheslaturan Guåhan* [the Guam Legislature].”

13 **Section 3.** A new § 1103 is *added* to Article 1 of Chapter 2, Title 5, Guam
14 Code Annotated, to read:

15 “§ 1103. **Compensation of *I Maga'låhen Guåhan*.** Notwithstanding
16 any other provision of law, rule, regulation, policy, or procedure, compensation of *I*
17 *Maga'låhen Guåhan* [the Governor of Guam] shall be paid at the rate of Ninety
18 Thousand Dollars (\$90,000) per annum.”

19 **Section 4.** A new § 2100.1 is *added* to Article 1 of Chapter 2, Title 5, Guam
20 Code Annotated, to read:

21 “§ 2100.1. **Compensation of *I Segundu na Maga'låhen Guåhan*.**
22 Notwithstanding any other provision of law, rule, regulation, policy, or
23 procedure, compensation of *I Segundu na Maga'låhen Guåhan* [the Lieutenant
24 Governor of Guam] shall be paid at the rate of Eighty-Five Thousand Dollars
25 (\$85,000) per annum.”

26 **Section 5. Effective Date.** The provisions of this Act *shall* become effective
27 ten days after enactment.
