PRUTEHI I HANOM ACT OF 2019 – AN ACT TO PROTECT THE WATERS OF GUAM BY AUTHORIZING THE ACQUISITION OF SPECIALIZED LEGAL SERVICES, ON A CONTINGENCY FEE BASIS, TO ASSIST IN ACTIONS TO ENSURE CLEAN AND SAFE WATER ON GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Title. This Act shall be known as the Prutehi I Hanom Act of 2019.
- Section 2. A new § 5004(c) is hereby *added* to Chapter 5, Subarticle A, of
- 5 Article 1, Title 5 of the Guam Code Annotated as follows:
- 6 § 5004 Application of this Chapter.
- 7 (c) This Chapter shall not apply to the Office of the Attorney General for
- 8 the acquisition of legal services for the pursuit of legal remedies for damage(s) to
- 9 Guam's groundwater, fish, wildlife, or marine resources, or protection of these
- 10 resources. An agreement for legal services executed for the before mentioned
- 11 <u>reasons shall provide:</u>

1	(1) that the parties agree to seek monetary and non-monetary relief,
2	such as remedial relief, in favor of the Government of Guam; and
3	(2) that contingency fees shall be calculated by the trial court using the
4	Lodestar Method to establish a reasonable hourly rate and number of
5	hours subject to such rate, not to exceed 30% of the final monetary and
6	non-monetary award obtained plus costs.
7	Section 3. Severability: If any provision of this Act or its application to any
8	person or circumstance is held invalid, the invalidity shall not affect other provisions
9	or applications of this Act that can be given effect without the invalid provision or
10	application and to this end the provisions of this Act are severable.
