AN ACT TO *ADD* A NEW § 26203.2 TO ARTICLE 2, CHAPTER 26, TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO PROVIDING LIMITED EXEMPTIONS TO SMALL BUSINESSES UNDER "THE DAVE SANTOS SMALL BUSINESS ENHANCEMENT ACT."

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new § 26203.2 is hereby *added* to Chapter 26, Division 2, Title

11, Guam Code Annotated, to read:

"§ 26203.2. Limited Exemption for Certain Small Businesses.

The taxes levied under this Article in excess of those generated from three percent (3%) of the gross proceeds of business privilege tax referenced in § 26202 shall not apply to the first Fifty Thousand Dollars (\$50,000) earned or received per taxable year by any person from real property rentals, retailing, service income, commission income, licensed insurance premium and/or farming, whose gross annual income is in excess of Fifty Thousand Dollars (\$50,000) but not more than Two Hundred Fifty Thousand Dollars (\$250,000) during the most recent tax year, provided, however, that such

person(s) shall be fully subject to three percent (3%) of the gross proceeds of business privilege tax referenced in § 26202, subject to the existing requirements and exemptions referenced elsewhere in this Article. The exemption set forth above shall apply annually, commencing on the first day of the month of the new tax year, based on the gross annual income of a person during the most recent year, and shall end on the last day of the last month of the same tax year."

Section 2. Severability. If any provision of this Act or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
