## BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Section 8, Chapter XI of Public Law 34-116 is hereby amended to read:

4 "Section 8. Guam Retirement Security Plan. The sum of Five Hundred

Thousand Dollars (\$500,000) Two Hundred One Thousand Four Hundred Sixty

Four Dollars (\$201,464) is hereby appropriated from the General Fund to fund the

Guam Retirement Security Plan established by Public Law 33-186."

Section 2. Appropriation to the Guam Election Commission, The sum

of Two Hundred Ninety-eight Thousand Five Hundred Thirty-six Dollars

(\$298,536) is appropriated from the General Fund in Fiscal Year 2019 to the Guam

Election Commission for the sole purpose of paying expenditures related to the

12 2018 Primary and General Elections. The sum of One Hundred Nine Thousand Six

Hundred Fifty Thousand Dollars (\$109,650) is authorized from the appropriation

14 in this Section to pay prior year obligations of the Guam Election Commission for

15 2018 Primary Election expenditures.

3	Section 4. Severability. If any provision of this Act or its application to							
4	any person or circumstance is held invalid, the invalidity shall not affect other
