AN ACT TO APPROPRIATE ONE MILLION TWO HUNDRED THOUSAND DOLLARS (\$1,200,000.00) FROM THE HEALTHY FUTURES FUND TO THE DEPARTMENT OF PUBLIC HEALTH AND SOCIAL SERVICES FOR THE OPERATIONS OF *I GUMA' MINA'ÁSE* FOSTER CARE FACILITY.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** The sum of One Million Two Hundred Thousand
3 Dollars (\$1,200,000.00) is appropriated from the Fiscal Year 2017 audited
4 available fund balance of the Healthy Futures Fund in Fiscal Year 2019 to the
5 Department of Public Health and Social Services for the operations of *I Guma'*
6 *Mina'áse* foster care facility. This appropriation shall be used by the government
7 of Guam to fund personnel, equipment, supplies, and contractual services required
8 for the health and safety of children at *I Guma' Mina'áse* foster care facility.
9 Notwithstanding any other provision of law, this appropriation shall continue to be
10 available until September 30, 2020, and is not subject to transfer or use for any
11 other purpose.

1 **Section 2. Severability.** *If* any provision of this Act or the application to
2 any person or circumstance is found to be invalid or contrary to law, such
3 invalidity *shall not* affect other provisions or applications of this Act that can be
4 given effect without the invalid provision or application, and to this end the
5 provisions of this Act are severable.
