AN ACT TO *ADD* A NEW § 25A204 TO ARTICLE 2 OF CHAPTER 25A OF TITLE 9, GUAM CODE ANNOTATED RELATIVE TO CREATING THE OFFENSE OF PRODUCTION OF CHILD PORNOGRAPHY AS A FIRST-DEGREE FELONY.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. A new § 25A204 is added to Article 2, Chapter 25A, Title 9, Guam
- 3 Code Annotated to read as follows:
- 4 "§ 25A204. Production of Child Pornography
- 5 (a) A person commits the offense of production of child pornography if, knowing
- 6 or having reason to know its character and content, the person produces,
- 7 manufactures, reproduces, copies, photographs, films, video tapes, video captures,
- 8 creates, directs, promotes, advertises publishes, issues or presents to show any
- 9 visual depiction, including any photograph, film, video, picture, or computer or
- 10 computer-generated image or picture, whether made or produced by electronic,
- mechanical, or other means, of sexually explicit conduct, where
- 12 (1) the production of such visual depiction involves the use of a minor 13 engaging in sexually explicit conduct; or
- 14 (2) such visual depiction is a digital image, computer image, or computer-
- generated image that is, or is indistinguishable from, that of a minor
- engaging in sexually explicit conduct; or

1	(3) such visual depiction has been created, adapted, or modified to appear
2	that an identifiable minor is engaging in sexually explicit conduct or
3	(4) visual material containing the display of sexual organs or activity of
4	minor that is intended to stimulate erotic feelings, or
5	(5) visual material containing the display of the sexual organs, female
6	breasts or buttocks of minor that is created by a violation of § 70.35 of
7	Article 1, Chapter 70, Title 9 Guam Code Annotated
8	(b) The fact that a person engaged in the conduct specified by this section is
9	prima facie evidence that the defendant had knowledge of the character and
10	content of the material. The fact that the person who was employed, used, or
11	otherwise contained in the pornographic material was, at that time, a minor is
12	prima facie evidence that the defendant knew the person to be a minor.
13	(c) A person who engaged in the production of child pornography outside of
14	Guam but is found to be in possession of the same child pornography on Guam
15	is guilty of Production of Child Pornography.
16	(d) Production of child pornography is a first degree felony."
