**AN ACT TO APPROPRIATE AN ADDITIONAL THREE MILLIION SEVEN HUNDRED THOUSAND DOLLARS (\$3,700,000) FOR THE CONSTRUCTION AND/OR RENOVATION OF SIMON SANCHEZ HIGH SCHOOL.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1. Legislative Findings and Intent.**

*I Liheslaturan Guåhan* finds that Simon Sanchez High School faces the combined challenges of deteriorating conditions, obsolescence, and overcrowding. These conditions are non-conducive to students' learning recognized in the Adequate Public Education Act. *I Liheslaturan Guåhan* finds that further delay on the construction of Simon Sanchez High School would continue to put the Department of Education in difficult budgetary constraints, which further threatens the quality of education provided to our public school students.

It is therefore the intent of *I Liheslaturan Guåhan* to dedicate funding towards completing the next phases of construction so our students are provided a safe and healthy environment that is conducive to learning.

**Section 2.** *I Maga'hågan Guåhan* is authorized to transfer a sum of Three Million Seven Hundred Thousand Dollars (\$3,700,000) from the General Fund

1 appropriations contained within Public Law 34-116 for the purpose outlined in  
2 Section 3.

3 **Section 3.** The funds *shall* be allocated for the procurement of an Owner's  
4 Agent Engineer (OAE), architectural and engineering (A&E) services, and other  
5 related services for the construction of a new Simon Sanchez High School pursuant  
6 to § 58D105, Chapter 58D, Title 5 GCA for Fiscal Year 2020.

7 **Section 4.** Notwithstanding any other provision of law, the allotted but  
8 unexpended balance of funds allocated to the Department of Education for Fiscal  
9 Year 2020 *shall not* lapse and *shall* continue to be available until fully expended.

10 **Section 5. Severability.** If any provision of this Act or its application to  
11 any person or circumstance is found to be invalid or contrary to law, such  
12 invalidity *shall not* affect other provisions or applications of this Act that can be  
13 given effect without the invalid provision or application, and to this end the  
14 provisions of this Act are severable.
