AN ACT TO ADD A NEW § 90.16.1 OF CHAPTER 90, TITLE 9, GUAM CODE ANNOTATED TO APPROPRIATE AN ADDITIONAL FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE UNAPPROPRIATED GENERAL FUND BALANCE AS OF THE END OF FISCAL YEAR 2019, TO THE DEPARTMENT OF CORRECTIONS TO CONDUCT A CORRECTIONAL OFFICER RECRUIT CYCLE FOR THE NEXT TWO (2) FICAL YEARS.

BE IT ENACTED BY THE PEOPLE OF GUAM

Section 1. Appropriation to the Department of Corrections. Up to the sum of Five Hundred Thousand Dollars (\$500,000) is appropriated from the unappropriated General Fund Balance, as of the end of Fiscal Year 2019, to the Department of Corrections for the purpose to conduct a correctional officer recruit cycle.

Section 2. A new § 90.16.1 of Chapter 90, Title 9, Guam Code Annotated, is hereby *added* to read:

“§ 90.16.1. Correctional Officer Recruit Cycle for Fiscal Years 2020 and 2021.

1 The Department of Correctios shall conduct a correctional officer
2 recruit cycle for a minimal of fifteen (15) candidates for the next two (2) fiscal
3 years, beginning in Fiscal Year 2020 and ending Fiscal Year 2021. Allocation
4 for the correctional officer recruit cycle is as follows:

5 (a) Five Hundred Thousand Dollars (\$500,000) from the Fiscal Year
6 2019's lapses *shall* be appropriated to the Department of
7 Correction's for a correctional officer recruit cycle during Fiscal
8 Year 2020.

9 (b) The Director of Corrections *shall*, for Fiscal Years 2021, determine
10 the total cost to conduct a correctional officer recruit cycle of at
11 least fifteen (15) candidates, which he shall transmit in his proposed
12 budget for Fiscal Year 2021 to *I Maga'Hagan Guãhan* for inclusion
13 in the Executive Budget request that *I Maga'Hagan Guãhan*
14 submits annually to *I Liheslaturan Guãhan*.

15 **Section 3.** Notwithstanding any other provision of law, the allotted but
16 unexpended balance of funds allocated to the Department of Corrections for
17 Fiscal Year 2020 *shall not* lapse and *shall* continue until fully expended.

18 **Section 4. Effective Date.** This Act *shall* become effective upon
19 enactment.

20 **Section 5. Severability.** If any provision of this Act or its application to
21 any 16 person or circumstance is held invalid, the invalidity *shall not* affect other
22 provisions or applications of this Act that can be given effect without the invalid
23 provision or application, and to this end the provisions of this Act are severable.
