AN ACT TO ADD A NEW § 90.16.1 OF CHAPTER 90, TITLE 9, GUAM CODE ANNOTATED TO APPROPRIATE AN ADDITIONAL FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE UNAPPROPRIATED GENERAL FUND BALANCE AS OF THE END OF FISCAL YEAR 2019, DEPARTMENT OF CORRECTIONS TO THE ТО CORRECTIONAL CONDUCT OFFICER RECRUIT A CYCLE FOR THE NEXT TWO (2) FICAL YEARS.

## **BE IT ENACTED BY THE PEOPLE OF GUAM**

Section 1. Appropriation to the Department of Corrections. Up to the
sum of Five Hundred Thousand Dollars (\$500,000) is appropriated from the
unappropriated General Fund Balance, as of the end of Fiscal Year 2019, to the
Department of Corrections for the purpose to conduct a correctional officer
recruit cycle.

Section 2. A new § 90.16.1 of Chapter 90, Title 9, Guam Code Annotated,
is hereby *added* to read:

9 <u>"§ 90.16.1. Correctional Officer Recruit Cycle for Fiscal Years 2020 and</u>
 10 <u>2021.</u>

The Department of Correctios shall conduct a correctional officer recruit cycle for a minimal of fifteen (15) candidates for the next two (2) fiscal years, beginning in Fiscal Year 2020 and ending Fiscal Year 2021. Allocation for the correctional officer recruit cycle is as follows:

- (a) Five Hundred Thousand Dollars (\$500,000) from the Fiscal Year
  2019's lapses *shall* be appropriated to the Department of
  Correction's for a correctional officer recruit cycle during Fiscal
  Year 2020.
- 9 (b) The Director of Corrections *shall*, for Fiscal Years 2021, determine 10 the total cost to conduct a correctional officer recruit cycle of at 11 least fifteen (15) candidates, which he shall transmit in his proposed 12 budget for Fiscal Year 2021 to *I Maga'Hagan Guåhan* for inclusion 13 in the Executive Budget request that *I Maga'Hagan Guåhan* 14 submits annually to *I Liheslaturan Guåhan*.

Section 3. Notwithstanding any other provision of law, the allotted but
 unexpended balance of funds allocated to the Department of Corrections for
 Fiscal Year 2020 *shall not* lapse and *shall* continue until fully expended.

18 Section 4. Effective Date. This Act *shall* become effective upon 19 enactment.

Section 5. Severability. If any provision of this Act or its application to any 16 person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
