AN ACT TO APPRORPIATE ONE MILLION DOLLARS (\$1,000,000) FROM THE UNAPPROPRIATED GENERAL FUND BALANCE, AS OF THE END OF FISCAL YEAR 2019, TO THE UNIFIED JUDICIARY OF GUAM.

## BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds

3 that the Unified Judiciary of Guam is in need of additional fiscal resources to ensure

their mandates are met with the greatest standards in support of all stakeholders. I

5 Liheslaturan Guåhan further finds that various needs of the Unified Judiciary must

be met to allow the third branch of government to execute its duties.

Therefore, it is the intent of I Liheslaturan Guåhan to appropriate from the

unappropriated General Fund balance, as of the end of Fiscal Year 2019, to the

Unified Judiciary of Guam for various services and programs.

Section 2. Appropriation to the Unified Judiciary of Guam. Up to the sum

of One Million Dollars (\$1,000,000) is appropriated from the unappropriated

General Fund Balance, as of the end of Fiscal Year 2019, to the Unified Judiciary of

Guam and is allocated as follows: Three Hundred Thousand Dollars (\$300,000) for

the Electronic Monitoring Program; Three Hundred Thousand Dollars (\$300,000)

- for Jury stipends; Thirty-five Thousand Dollars (\$35,000) for Marshal equipment &
- 2 supplies; Fifty Thousand Dollars (\$50,000) for Maintenance and Information
- 3 Technology services; Thirty Thousand Dollars (\$30,000) for the Therapeutic Courts
- 4 Drug testing supplies and materials; Thirty-five Thousand Dollars (\$35,000) for the
- 5 Therapeutic Courts Counseling Services; and Two Hundred Fifty Thousand Dollars
- 6 (\$250,000) for the additional courtroom and equipment to support an eighth (8<sup>th</sup>)
- 7 Judge. The appropriation in this Section shall not lapse and shall continue until fully
- 8 expended.
- 9 Section 3. Effective Date. This Act shall become effective upon enactment.
- Section 4. Severablility. If any provision of this Act or its application to any
- person or circumstance is held invalid, the invalidity *shall not* affect other provisions
- or applications of this Act that can be given effect without the invalid provision or
- application, and to this end the provisions of this Act are severable.
