





AN ACT TO APPROPRIATE ONE MILLION DOLLARS (\$1,000,000) FROM THE UNAPPROPRIATED GENERAL FUND BALANCE, AS OF THE END OF FISCAL YEAR 2019, TO THE OFFICE OF THE ATTORNEY GENERAL OF GUAM.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Office of the Attorney General of Guam is in need of additional fiscal
4 resources to accomplish their goals in ensuring the various programs they administer
5 and mandates are satisfactorily accomplished. Of greatest importance is the need to
6 enhance software technology for child support payments and claims, ensuring the
7 beneficiaries of child support remittances are remitted promptly from one parent to
8 the other. *I Liheslaturan Guåhan* further finds that this software will assist the Office
9 of the Attorney General of Guam in maintaining compliance for reimbursements and
10 other responsibilities relative to child support processing.

11 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate from the
12 unappropriated General Fund balance, as of the end of Fiscal Year 2019, to the
13 Office of the Attorney General of Guam for Child Support Case Management
14 Software.

1 **Section 2. Appropriation to the Office of the Attorney General of Guam.**

2 Up to the sum of One Million Dollars (\$1,000,000) is appropriated from the
3 unappropriated General Fund Balance, as of the end of Fiscal Year 2019, to the
4 Office of the Attorney General of Guam, for the purpose of procuring Child Support
5 Case Management Software. The appropriation in this Section *shall not* lapse and
6 *shall* continue until fully expended.

7 **Section 3. Effective Date.** This Act *shall* become effective upon enactment.

8 **Section 4. Severability.** If any provision of this Act or its application to any
9 person or circumstance is held invalid, the invalidity *shall not* affect other provisions
10 or applications of this Act that can be given effect without the invalid provision or
11 application, and to this end the provisions of this Act are severable.
