**AN ACT TO APPROPRIATE ONE MILLION DOLLARS  
(\$1,000,000) FROM THE UNAPPROPRIATED GENERAL  
FUND BALANCE, AS OF THE END OF FISCAL YEAR  
2019, TO THE UNIVERSITY OF GUAM.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds that on October 16, 2019, the University of Guam Board of Regents adopted and approved a tuition increase of up to Five percent (5%) each semester beginning in the *Fañomnakan* Semester in 2020 through *Fanuchånan* Semester 2021 and that in order to maintain the enrollment numbers, the University of Guam must continue to obtain appropriations from the government of Guam. *I Liheslaturan Guåhan* further finds that various areas of the University of Guam require minimal investments for improvements.

Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate from the unappropriated General Fund balance, as of the end of Fiscal Year 2019, to the University of Guam to assist in the control of the tuition increase and provide the University of Guam with additional resources to accomplish its goals.

1           **Section 2. Appropriation to the University of Guam.** Up to the sum of One  
2 Million Dollars (\$1,000,000) is appropriated from the unappropriated General Fund  
3 balance, as of the end of Fiscal Year 2019, and is allocated as follows: Four Hundred  
4 Thousand Dollars (\$400,000.00) for air conditioning repairs; Two Hundred Ten  
5 Thousand Dollars (\$210,000.00) for voice over internet protocol system; Three  
6 Hundred Thousand Dollars (\$300,000.00) to replace disfunctional generator at the  
7 Office of Information Technology; and, Ninety Thousand Dollars (\$90,000.00) for  
8 Information Technology infrastructure improvements and increase campus network  
9 speed capabilities. The appropriation in this Section *shall not* lapse and *shall*  
10 continue until fully expended.

11           **Section 3. Effective Date.** This Act *shall* become effective upon enactment.

12           **Section 4. Severability.** If any provision of this Act or its application to any  
13 person or circumstance is held invalid, the invalidity *shall not* affect other provisions  
14 or applications of this Act that can be given effect without the invalid provision or  
15 application, and to this end the provisions of this Act are severable.
