AN ACT RELATIVE TO INITIATING THE RECALL ELECTION OF THE MAYOR OF THE VILLAGE OF YONA AND AN ACT TO AMEND § 1013.1 OF CHAPTER 10, TITLE 1, GUAM CODE ANNOTATED, RELATIVE TO INCLUDING THE RESULTS OF A RECALL ELECTION IN EVENTS CAUSING VACANCY IN MUNICIPAL OFFICES.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

3 I Liheslaturan Guåhan finds that on November 8, 2016, there were 1,775

- 4 total votes cast for the position of Mayor of the Village Yona and the Honorable
- 5 Jesse Blas received a total of 1,575 (One Thousand Five Hundred Seventy-Five)
- 6 votes to be declared the Mayor of the Municipality of Yona.

7 I Liheslaturan Guåhan further finds that on September 18, 2019, the

indictment of the Honorable Jesse Blas was filed in the District Court of Guam

thus placing the Honorable Mayor of Yona on annual leave. Since the

confinement of the Honorable Mayor, the people and community of the

11 Municipality of Yona have been without the critical leadership of a Mayor that is

recognized under § 40112 of Article 1, Chapter 40, Title 5, Guam Code Annotated.

4	Section 2. Mandate and Appropriation for a Recall Election to remove
5	the current Mayor of Yona from the Municipality of Yona.
6	(a) Pursuant to §1121 of Chapter 1, Title 3 GCA, I Mina'trentai
7	Singko Na Liheslaturan Guåhan initiates a recall election of Jesse Blas,
8	Mayor of the Village of Yona. I Mina'trentai Singko Na Liheslaturan
9	Guahan mandates that the Guam Election Commission submit to the voters
10	of the Municipality of Yona the following question during the recall
11	election:
12	"SHALL THE MAYOR OF THE MUNICIPALITY OF
13	YONA, JESSE BLAS BE REMOVED FROM OFFICE

16	(b) Up to the sum of Twenty-two Thousand Eight Hundred

20	Section 3. § 1013.1 of Chapter 10, Title 1, Guam Code Annotated, is
21	amended to read:
22	§ 13106. Events Causing Vacancy in the Municipal Offices of
23	Mayor and Vice Mayor.
24	The municipal offices of Mayor and Vice Mayor become vacant on
25	the happening of any of the following events:

1	(a) death of the incumbent;
2	(b) declaration of mental incompetence by a final judgment or final
3	order of a court of competent jurisdiction;
4	(c) resignation from office;
5	(d) refusal or failure to assume office;
6	(e) the decision of a competent tribunal declaring void his or her
7	election;
8	(f) conviction of a felony, or of a crime involving moral turpitude;
9	(g) his or her change of residence from the municipality in which he
10	or she was elected;
11	(h) when an incumbent is incapacitated because of illness and unable
12	to continue for the remainder of the term to which he or she was elected; or
13	(i) when an incumbent has sought and won election to another office
14	and assumed the new office, constituting voluntary relinquishment of the
15	original office-; or
16	(j) the results of a recall election, in accordance with § 1121 of
17	Chapter 1, Title 3 Guam Code Annotated, if in favor of removal of the
18	incumbent.
19	The occurrence of any event under (a) through (i), with respect to a
20	person or persons elected to office, after the election but before the term of
21	office is to commence, constitutes a vacancy on the date the term
22	commences, unless the person or persons so elected is the incumbent, in
23	which case, the vacancy occurs on the date of such event.
24	Section 4. Effective Date. This act shall be effective upon enactment.
