AN ACT TO APPROPRIATE TWENTY EIGHT THOUSAND DOLLARS (\$28,000) FROM THE UNAPPROPRIATED GENERAL FUND BALANCE, AS OF THE END OF FISCAL YEAR 2019, TO THE GUAM ELECTION COMMISSION FOR THE PURPOSE OF CONDUCTING A SPECIAL ELECTION FOR THE OFFICE OF MAYOR OF THE MUNICIPALITY OF YO'ÑA.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Office of the Mayor of the Municipality of *Yo'ña* was declared vacant by
4 the Guam Election Commission on Tuesday, February 4, 2020, after the resignation
5 of Mayor Jesse Blas, on Thursday, January 30, 2020. *I Liheslaturan Guåhan* further
6 finds that the Guam Election Commission, in their declaration and pursuant to Guam
7 law, must conduct a Special Election to fill the vacancy.

8 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate from the
9 unappropriated fund balance, as of the end of Fiscal Year 2019, to the Guam Election
10 Commission to fund the cost of a Special Election to fill the vacancy in the Office
11 of the Mayor of the Municipality of *Yo'ña* on Saturday, March 28, 2020.

12 **Section 2. Appropriation to the Guam Election Commission.** Up to the
13 sum of Twenty Eight Thousand Dollars (\$28,000) is appropriated from the
14 unappropriated General Fund Balance, as of the end of Fiscal Year 2019, to the

1 Guam Election Commission to conduct a Special Election to fill the vacancy of the
2 Office of Mayor in the Municipality of *Yo'ña*. The appropriation in this Section
3 *shall not* lapse and *shall* continue until fully expended.

4 **Section 3. Effective Date.** This Act *shall* become effective upon enactment.

5 **Section 4. Severability.** If any provision of this Act or its application to any
6 person or circumstance is held invalid, the invalidity *shall not* affect other provisions
7 or applications of this Act that can be given effect without the invalid provision or
8 application, and to this end the provisions of this Act are severable.
