AN ACT TO AMEND CHAPTER 26 OF TITLE 11, GUAM CODE ANNOTATED RELATIVE TO THE TEMPORARY REDUCTION OF THE LIQUID FUEL TAX.

1 BE IT ENACTED BY THE PEOPLE OF GUAM: Section 1. Chapter 26 of Title 11, Guam Code Annotated is hereby amended to read 2 3 as follows: 4 § 26403. Rates. Notwithstanding the requirements of § 16311 of Article 3, Chapter 16, Title 5 6 3, Guam Code Annotated, and any other provision of law, the following rates shall apply in computing, assessing, and collecting the liquid fuel tax, effective January 7 1, 2018: 8 9 (a) a tax at the rate of Fourteen Cents (\$0.14) per gallon on diesel fuel, however between April 1, 2020 and September 30, 2020, the tax rate shall be 10 Ten Cents (\$0.10) per gallon; and 11 (b) a tax at the rate of Fifteen Cents (\$0.15) per gallon on all other liquid 12 13 fuel as defined herein except liquid fuel used for commercial aviation purposes which is taxed at a rate of Eight Cents (\$0.08) per gallon. However 14 15 between April 1, 2020 and September 30, 2020, the tax rate for all other liquid

1	fuel defined herein, except liquid fuel used for commercial aviation purposes.
2	shall be Eleven Cents (\$0.11) per gallon.

3 Severability. If any provision of this Act or its application to any Section 2. 4 person or circumstance is found to be invalid or contrary to law, such invalidity shall 5 not affect other provisions or applications of this Act that can be given effect without 6

the invalid provision or application, and to this end the provisions of this Act are

7 severable.

Section 3. Effective Date. The Act shall become effective on April 1, 2020.
