AN ACT TO ADD A NEW § 4125 TO CHAPTER 4 OF DIVISION 1, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO PROVIDING FOR TRANSPARENCY AND ACCOUNTABILITY IN THE USE OF U.S. GOVERNMENT AND GOVERNMENT OF GUAM FUNDS FOR COVID-19 RESPONSE EFFORTS, BY REQUIRING WEEKLY FINANCIAL REPORTS.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. A new § 4125 is added to Chapter 4 of Division 1, Title 5,
- 3 Guam Code Annotated, to read:
- 4 "§ 4125. COVID-19 Financial Reporting Requirement.
- Notwithstanding any other provision of law, the Director of Administration
- 6 shall submit weekly financial reports to I Liheslaturan Guåhan summarizing all
- 7 expenditures associated with the COVID-19 public health emergency, including
- 8 the receipt and expenditure of COVID-19 funds issued to Guam by the U.S.
- 9 Government. In addition to the Director of Administration, the Director of the
- 10 Bureau of Budget and Management Research and the Director of Revenue and
- 11 Taxation shall certify said reports, which shall be transmitted to I Maga'håga
- 12 <u>Guåhan and the Speaker of I Liheslaturan Guåhan no later than five (5) business</u>
- 13 <u>days after the end of each week.</u>"

Section 2. Effective Date. This Act shall become effective immediately upon enactment. A financial report covering all receipts and expenditures for the period of March 1, 2020 and until the date of enactment of this Act shall be submitted to *I Maga'håga Guåhan* and the Speaker of *I Liheslaturan Guåhan* within ten (10) business days immediately following enactment of this Act.
