

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2	Section 1. Findings and Intent. I Liheslatura finds that this				
3	legislation is required to expend over a two hundred thousand in federal				
4	funds that are already in hand to design and build a mass transit facility				
5	to improve services to the people of Guam.				
6	Section 2. Grant of Administrative Jurisdiction of a Two				

- (2) Acre Portion of Parcel 5109 R2, Municipality of *Tamuning* to
 the Guam Regional Transit Authority.
- 9 (a) Administrative Jurisdiction of a Two (2) Acre Portion of
 10 Parcel 5109-R2, Municipality of *Tamuning* as shown on Map
 11 055FY2014 is hereby granted to the Guam Regional Transit Authority
 12 for the purpose of developing and constructing a *maintenance and*13 *office facility* for the use of the Guam Regional Transit Authority and
 14 the People of Guam.

1	(b) If the property is not developed into a functioning
2	maintenance facility and office within Three (3) years, administrative
3	jurisdiction of the Guam Regional Transit Authority shall expire, and
4	the property shall revert back to the inventory of the Chamorro Land
5	Trust.
6	(c) A survey map designating the Two (2) Acre portion of
7	5109-R2 has already been prepared, recorded, and provided by the
8	Department of Land Management to the Guam Regional Transit
9	Authority. The location of the 2-acre portion in Parcel 5109-R2 shall
10	be at the discretion of the Guam Regional Transit Authority.
11	Section 3. Exemption from Appraisals. 2 GCA § 2107(b) relative
12	to land appraisals, do not apply to this Act.
13	Section 4. Severability. If any of provision of this law or its
14	application to any person or circumstance is found to be invalid or contrary
15	to law, that invalidity shall not affect other provisions or applications of this
16	law, which can be given effect without the invalid provisions or applications

and to this end the provisions of this act are severable.
