## BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent.

I Liheslaturan Guåhan finds that each member of the Guam Department of Education Financial Supervisory Commission (EFSC) is fined Two Hundred Fifty Dollars (\$250) in any month the commission fails to meet.

It is the intent of *I Liheslaturan Guåhan* to clarify that the Two Hundred Fifty Dollar (\$250) fine shall only apply to members not in attendance at an EFSC meeting when such absence results in no quorum.

**Section 2.** § 3133(b)(5) of Chapter 3, Title 17, Guam Code Annotated, is *amended* to read:

"(5) Failure of the EFSC to meet in any month shall result in a Two Hundred Fifty Dollars (\$250) fine for each member <u>absent from an EFSC meeting</u>. The fine shall be imposed on the absent member for every meeting missed that resulted in a <u>lack of quorum</u>. Such fine shall be deposited into the GDOE Interscholastic Sports

Program."

Section 3. Effective Date. This act shall be effective upon enactment.
