- 5 Enrollment for Employment Pursuant to § 8121(a), Chapter 8, Title 4 GCA.
- 6 Any employee hired pursuant to § 8121(a), Article 1, Chapter 8, Title 4 GCA, shall
- 7 only be eligible to enroll in the Government of Guam Health Insurance Program as
- 8 an active employee. This restriction shall not apply to a person who at the time of
- 9 hiring is currently enrolled in Medicare Parts A & B and has selected either Class I
- or Class II of the Retiree Supplemental Plan (RSP)."
