**AN ACT TO APPROPRIATE TWO HUNDRED THIRTY EIGHT THOUSAND ONE HUNDRED AND NINETY DOLLARS AND SEVENTY CENTS (\$238,190.70) FROM THE GCC ENDOWMENT FUND SERIES 2001 B TO THE GUAM COMMUNITY COLLEGE PURSUANT TO §221306 OF ARTICLE 13 OF CHAPTER 22 OF TITLE 5 OF THE GUAM CODE ANNOTATED FOR FISCAL YEAR 2020.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds that  
3 the Guam Community College (GCC) is essential to developing, cultivating, and  
4 producing educated citizens. GCC serves as a higher education institution with a  
5 purpose of advancing careers and technical education, not only for residents of  
6 Guam but for individuals from the entire Asia-Pacific region.

7 Furthermore, *I Liheslaturan Guåhan* finds that during FY 2009 GCC received  
8 funds from the GCC Endowment Fund Series 2001 B. The requested funds were  
9 used on construction of a parking lot. Additional funds were used to purchase  
10 multiple Dell Power Edge T410 servers to better assist student, faculty, and visitors.  
11 These upgrades were necessary given the increasing development and enrollment at  
12 GCC.

1           Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate funds from  
2 the earnings of the GCC Endowment Fund Series 2001 B, as of the end of fiscal year  
3 2019, to the Guam Community College.

4           **Section 2. Appropriation to the Guam Community College.** Up to the  
5 sum of Two Hundred Thirty Eight Thousand One Hundred and Ninety Dollars and  
6 Seventy Cents (\$238,190.70) is appropriated from the GCC Endowment Fund Series  
7 2001 B, as of the end of Fiscal Year 2019, to the Guam Community College for the  
8 enumerated in §221306 of Article 13 of Chapter 22 of Title 5 of the Guam Code  
9 Annotated.
