AN ACT TO APPROPRIATE FOUR HUNDRED THIRTY THREE THOUSAND DOLLARS (\$433,000) FROM THE EARNINGS OF THE UOG HIGHER EDUCATION ENDOWMENT FUND TO THE UNIVERSITY OF GUAM PURSUANT TO \$221305 OF ARTICLE 13 OF CHAPTER 22 OF TITLE 5 OF THE GUAM CODE ANNOTATED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds that the
University of Guam (UOG) is essential to developing, cultivating, and producing educated
citizens. UOG serves as a higher education institution with a purpose of serving the people
of Guam and the whole Micronesian region. During FY 2006 and 2008 the University
utilized funds from the UOG Higher Education Endowment Fund to make improvements
to the RFK Public Library. Additionally, UOG used requested funds to purchase library
equipment to modernize the necessary area for students, visitors, and faculty.

Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate funds from the earnings of the University of Guam Higher Education Endowment Fund, as of the end of fiscal year 2019, to the University of Guam.

Section 2. Appropriation to the University of Guam. The sum of up to Four Hundred Thirty Three Thousand Dollars (\$433,000) is appropriated from the UOG Higher Education Endowment Fund, as of the end of Fiscal Year 2019, to the
