Section 1. § 10003(mm)(2), Chapter 10, Division 1, Title 26 GARR is

- "(2) At least fifty-one percent (51%) of the licensed medical cannabis business *shall* retain ownership by legal residents of Guam who have maintained continuous legal residential address or addresses on Guam for a period of *no less than three* (3) one (1) year[s] prior to the application for a medical cannabis license. This requirement *shall not* apply to any person or associations of persons applying

Section 2. § 10208(a), Chapter 10, Division 1, Title 26 GARR is amended to read:

"(a) Legal residents of Guam who have maintained continuous legal residential address(es) on Guam for a period of *no less than* three (3) one (1) year[s] prior to the application for a medical cannabis license *shall* retain at least fifty-one percent (51%) ownership of the medical cannabis business, pursuant to 10 GCA, Division 1, Chapter 12 Part 2, Article 25, § 122508. This requirement *shall not* apply

- 1 to any person or associations of persons applying for a license to laboratory test
- 2 <u>cannabis.</u>"
- 3 Section 3. Effective Date. This Act shall become effective upon enactment
