**AN ACT TO ADD A NEW (c) TO § 61660 OF SUBARTICLE  
5 OF CHAPTER 61, TITLE 21, GUAM CODE ANNOTATED,  
RELATIVE TO AMENDING FEE SCHEDULE FOR ZONE  
CHANGES, VARIANCES, CONDITIONAL USE,  
SUBDIVISION VARIANCE, APPEALS AND OTHER  
SERVICES THROUGH THE DEPARTMENT OF LAND  
MANAGEMENT AND GUAM LAND USE COMMISSION.**

**BE IT ENACTED BY THE PEOPLE OF GUAM**

**Section 1.** A new (c) is hereby added to §61660 of Subarticle 5 of Chapter  
61, Title 21, Guam Code Annotated, to read:

“(c) To better reflect the extensive processing, research, and review that  
the Department of Land Management personnel and Guam Land Use  
Commission jointly undertake relative to applications for zone change, zone  
variance, conditional use, subdivision variance, appeals and other services,  
the Director of the Department of Land Management is hereby authorized to  
amend the schedule of fees established in Subarticle 5 of Chapter 61 of Title  
21, Guam Code Annotated, or establish new fees for services, pursuant to the  
Administrative Adjudication Law. The Guam Land Use Commission may  
consult with or submit requests to the Director of Land Management for the  
establishment of additional fees or amendment to fees. All money received  
pursuant to this Section shall be deposited in the Department of Land  
Management Land Survey Revolving Fund (LSRF).”
