
CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LÅHEN GUÅHAN



**AN ACT TO AMEND SUBSECTIONS (C), (E), (F) AND
(G), AND ADD A NEW SUBSECTION (H) OF SECTION
2(1) OF PUBLIC LAW 32-053, RELATIVE TO
APPROPRIATING FUNDS FROM THE
UNAPPROPRIATED GUAM HIGHWAY FUND
REVENUES IN FISCAL YEAR 2015 AND GUAM
HIGHWAY FUND BALANCE TO THE DEPARTMENT
OF PUBLIC WORKS FOR FLOOD MITIGATION AND
OTHER CAPITAL IMPROVEMENT PROJECTS
RELATED TO IMPROVING THE ROADS OF GUAM.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any provision of law, the

3 sum of Five Hundred Fifty Thousand Dollars (**\$550,000**) is hereby appropriated

1 from the unappropriated Guam Highway Fund revenues in Fiscal Year 2015 and
2 Three Hundred Ninety Thousand Dollars (**\$390,000**) from the unappropriated fund
3 balance of the Guam Highway Fund to the Department of Public Works (DPW), as
4 specifically provided in Section 2 of this Act.

5 **Section 2.** Subsections (C), (E), (F), and (G) are *amended*, and a new
6 Subsection (H) is *added* to Section 2(1) of Public Law 32-053 to read as follows:

7 “(C) Lot 6-1, Block 2, municipality of *Barrigada* (Route 8), as
8 directed by the Director of DPW up to \$550,000”

9 “(E) Various flood mitigation and road repair and pavement work in
10 the village of *Yigo*, as directed by the Mayor of *Yigo* up to \$300,000”

11 “(F) Lot 1019-5-4 and 1019-5-3, municipality of *Barrigada*, as
12 directed by the Mayor of *Barrigada* to \$300,000”

13 “(G) Flood Mitigation and road repair and pavement projects around
14 the island, as directed by the Director of DPW and as prescribed in Exhibit
15 “A” through “R” of this Act. Road repair and pavement projects *shall* be
16 directed by the DPW Director and *shall* commence with improvements to
17 *Chalan Maimai* Street in *Chalan Pago*, Swamp Road in *Dededo*, *Lalo* Street
18 in *Mangilao*, and *Chalan Frijoles* Street in *Dededo* \$300,000”

19 “(H) Purchase of Lot 10-20 (Exhibit “A”), municipality of *Agaña*
20 *Heights*, to continue to be used as a government ponding basin in order to
21 control flooding in the village \$120,000”
