AN ACT TO APPROPRIATE ONE MILLION ONE HUNDRED SEVENTY FIVE THOUSAND DOLLARS (\$1,175,000) FROM THE **UNRESERVED FUND BALANCE OF THE HEALTHY FUTURES FUND, AS OF** SEPTEMBER 30, 2015, TO THE GUAM MEMORIAL AUTHORITY (GMHA) HOSPITAL FOR THE **PAYMENT OF GMHA OUTSTANDING GUAM POWER** AUTHORITY AND **GUAM** WATERWORKS AUTHORITY OBLIGATIONS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Appropriation for Guam Memorial Hospital Authority
Utilities. Notwithstanding the provisions of Chapter 26, § 26602(d) Title 11,
Guam Code Annotated, the sum of One Million One Hundred Seventy-Five

Thosuand Dollars (\$1,175,000) is appropriated from the unreserved surplus of the 1 2 Healthy Futures Fund, as of September 30, 2015, to the Guam Memorial Hospital 3 Authority (GMHA) for the sole purpose of funding outstanding Guam Power 4 Authority (GPA) and Guam Waterworks Authority (GWA) utility obligations. Notwithstanding any other provision of law, the Director of Administration shall 5 remit the funds appropriated herein directly to the GPA and GWA as payment on 6 7 behalf of the GMHA not later than three (3) calendar days after the enactment of 8 this Act and shall report such payment to the Speaker of I Liheslaturan Guåhan 9 and I Maga'låhen Guåhan not later than one (1) day after such payment is made. Notwithstanding any other provision of law, this appropriation shall continue to be 10 11 available until fully expended and is not subject to transfer or use for any other 12 purpose.

13 Section 2. Effective Date. This Act *shall* become effective upon
14 enactment.

15 Section 3. Severability. *If* any provision of this Act or its application to 16 any person or circumstance is held invalid, the invalidity *shall not* affect other 17 provisions or applications of this Act that can be given effect without the invalid 18 provision or application and to this end the provisions of this Act is severable.
