### AN ACT TO *ADD* A NEW ITEM (8) TO SUBSECTION (m) OF SECTION 1, CHAPTER V OF PUBLIC LAW 33-66, RELATIVE TO PROVIDING AUTHORIZATION TO THE GUAM POLICE DEPARTMENT FOR PROMISED COMPENSATION OBLIGATIONS INCURRED IN PRIOR FISCAL YEARS.

#### **BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. A new Item (8) is hereby *added* to Section 1(m) of Chapter V of
Public Law 33-66 to read:

4 "(8) Prior Year Obligations for Promised Compensation
5 Authorized. The Guam Police Department is authorized to use funds from

the appropriations made in Subsection (m) of Section 1 of this Chapter for the 1 2 payment of prior year obligations. I Maga'låhen Guåhan shall identify and 3 transfer to the Guam Police Department, from any appropriations in this Chapter V not restricted from his transfer authority, the aggregate sum 4 necessary for the payment of prior year obligations for promised 5 6 compensation. The Director of the Bureau of Budget and Management Research shall notify the Speaker of I Liheslaturan Guåhan no later than five 7 (5) working days before such transfer is made, which shall include the amount 8 9 being transferred and the names of the department and/or agency, and division of such department and/or agency, from which such appropriation is being 10 transferred. Included in this notification to the Speaker of I Liheslaturan 11 Guåhan, the BBMR Director shall also certify that the appropriations being 12 13 transferred will not negatively impact the operations of the department and/or 14 agency from which appropriations are being transferred to the GPD. If such 15 notification is not provided by the Director of the Bureau of Budget and 16 Management Research to the Speaker of I Liheslaturan Guåhan by the five 17 (5) working days prior to such transfer taking place as specified herein, such 18 transfer authority shall not be authorized."
