AN ACT TO AUTHORIZE THE EXPENDITURE OF UP TO THIRTY THOUSAND DOLLARS (\$30,000) FROM THE CHAMORRO LAND TRUST SURVEY AND INFRASTRUCTURE FUND FOR THE DESIGN AND INSTALLATION OF POWER INFRASTRUCTURE IN BASIC LOT 480, SANTA ANA, MUNICIPALITY OF AGAT.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds 3 that the entire subdivision of Basic Lot 480, *Santa Ana*, municipality of *Agat*, as 4 shown in the Department of Land Management Map Drawing No. 2213-11-14 5 recorded under Document No. 880921 (Exhibit A), and further outlined in Satellite

1 Overlay Map (Exhibit B), belongs to the Chamorro Land Trust Commission 2 (CLTC). Although the Guam Power Authority (GPA) had previously installed power lines into the area, approximately ten percent (10%) of the area remains to be 3 serviced. Currently, there are fifty-three (53) surveyed lots in the subdivision. There 4 5 are lessees residing in the area without GPA electrical service, and they generate 6 electrical power by gasoline generators. Numerous CLTC lessees in the area have come forward requesting for assistance in obtaining electrical power for their 7 8 respective lots. The Santa Ana, Agat area seems to have high resident potential with 9 a minimal investment of system development charges. Preliminary system 10 development planning has already been done by GPA.

I Liheslaturan Guåhan further finds that there has been a total of 11 approximately One Hundred Twenty-Three Thousand Dollars (\$123,000) collected 12 in FY 2016 pursuant to Public Law 33-104 and Public Law 33-90. Public Law 33-13 14 104 authorized the extension for payment of expired Land for the Landless contracts 15 and the transfer of Land for the Landless lots to the Chamorro Land Trust 16 Commission land inventory. Public Law 33-90 authorized the sale of bull cart trails 17 and land remnants. All proceeds from both public laws are to be deposited to the 18 Chamorro Land Trust Survey and Infrastructure Fund, identified as Department of Administration Revenue Account Number 3669-57001, CLT-Sale of Government 19 20 Land.

I Liheslaturan Guåhan intends to use part of these funds for the installation
of power infrastructure in Basic Lot 480, *Santa Ana*, municipality of *Agat*, to provide
the basic necessities of life for the CLTC lessees within the subdivision.

Section 2. Authorization to Expend.

(a) The Chamorro Land Trust Commission (CLTC) is hereby
authorized to expend up to Thirty Thousand Dollars (\$30,000) from the
Chamorro Land Trust Survey and Infrastructure Fund, identified as

1 Department of Administration Revenue Account Number 3669-57001, CLT-2 Sale of Government Land, for the design and installation of power 3 infrastructure in Basic Lot 480, *Santa Ana*, municipality of *Agat*, as shown in 4 GPA Systems Overlay Map (Exhibit C). Upon completion of the design and 5 installation of power infrastructure, unexpended amounts *shall* be returned to 6 the *Chamorro Land Trust Survey and Infrastructure Fund* and made available 7 for subsequent appropriations.



(b) The CLTC *shall* coordinate with the Guam Power Authority (GPA) for the design and installation of power infrastructure within thirty (30) days of the enactment of this Act.

11 Section 3. Severability. If any provision of this law or its application to 12 any person or circumstance is found to be invalid or contrary to law, such invalidity 13 *shall not* affect other provisions or applications of this law which can be given effect 14 without the invalid provisions or applications, and to this end the provisions of this 15 law are severable.
