



1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new § 51303(c) is *added* to Article 3 of Chapter 51, Title 10,

3 Guam Code Annotated, to read:

1           “(c) The Department of Administration *shall* prepare and transmit to  
2 the Guam Environmental Protection Agency a weekly report on the current  
3 balance and transactions of the Recycling Revolving Fund. The Guam  
4 Environmental Protection Agency *shall* post this information on its website  
5 as it becomes available.”
