1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. A new § 19.80 is added to Chapter 19, Title 9, Guam Code
- 3 Annotated, to read:
- 4 "§ 19.80. Strangulation; Defined & Punished.

1	(a) A person is guilty of strangulation if he knowingly or						
2	intentionally, against the will of another, impedes the normal breathing or						
3	circulation of the blood of another by applying pressure to the throat or necl						
4	or by blocking the nose or mouth of another.						
5	(b) Strangulation is a felony of the third degree; provided, that any						
6	person convicted of strangulation shall not be eligible for work release of						
7	educational programs outside the confines of prison."						
8	Section 2. A new § 30.10 (a)(3) is added to Chapter 30, Title 9, Guam Code						
9	Annotated, to read:						
10	"(3) Knowingly or intentionally, against the will of another,						
11	impeding the normal breathing or circulation of the blood of a family						
12	or household member by applying pressure to the throat or neck or by						
13	blocking the nose or mouth of a family or household member."						
14	Section 3. Effective Date. This Act shall become effective upon						

enactment.
