AN ACT TO REZONE LOT 2168, MUNICIPALITY OF *BARRIGADA*, FROM AGRICULTURAL ZONE (A) TO LIGHT INDUSTRIAL ZONE (M1).

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
 that it is the desire of the owners of Lot 2168 to develop their Tiyan property to
 maximize its highest potential. With the passage of Public Law 31-198, all federal
- 5 excess lands that were returned to the original landowners were designated as

- 1 Agricultural Zone (A). Like many other Tiyan properties, Lot 2168 was used for
- 2 purposes other than agricultural.
- Therefore, in an effort to assist the landowners to maximize the highest and
- 4 best use of their property, it is the intent of *I Liheslaturan Guåhan* to authorize the
- 5 rezoning of the lot described herein for the purposes of maintaining continued
- 6 development and appropriate use of the property.
- 7 Section 2. Lot Rezoned. Notwithstanding 21 GCA § 61637, Lot 2168,
- 8 containing an area of 90,747 +/- square meters, located in *Tiyan* municipality of
- 9 Barrigada, as shown on Department of Land Management Drawing No. 063-
- 10 FY2007, recorded under Document No. 683594 (Attachment A), is hereby rezoned
- 11 from Agricultural Zone (A) to Light Industrial Zone (M1). This Section shall be
- subject to the provisions of § 61202, Chapter 61, Title 21 GCA.
- 13 Section 3. Effective Date. This Act shall take effect upon its enactment
- 14 into law.
