AN ACT TO *ADD* NEW SECTIONS 15 AND 16 TO PART II OF CHAPTER III; NEW SECTIONS 4 AND 5 TO PART III OF CHAPTER III; AND NEW SUBSECTIONS 1(m)(7), 1(n)(7), AND 1(aa)(5) OF CHAPTER V, ALL OF PUBLIC LAW 33-185, RELATIVE TO PRIORITIZING AND MAINTAINING THE FUNDING LEVELS APPROPRIATED TOWARD SAFETY AND HEALTH AGENCIES IN FISCAL YEAR 2017.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. New Sections 15 and 16 are hereby *added* to Part II of Chapter

- 3 III of Public Law 33-185 to read:

"Section 15. Appropriation Reserve Restriction. The BBMR shall

not have the authority to place any appropriations reserves on any General

Fund, Healthy Futures Fund, Environmental Health Fund, and Sanitary
 Inspection Revolving Fund appropriations in Section 1 of this Part of this
 Chapter.

Section 16. Transfer Authority Restrictions. Notwithstanding any
other provision of law and this Act, *I Maga'låhen Guåhan shall not* be
authorized to transfer any General Fund, Healthy Futures Fund,
Environmental Health Fund, and Sanitary Inspection Revolving Fund
appropriations in Section 1 of this Part of this Chapter to any other department
or agency of the government of Guam."

Section 2. New Sections 4 and 5 are hereby *added* to Part III of Chapter III
of Public Law 33-185 to read:

"Section 4. Appropriation Reserve Restriction. The BBMR *shall not* have the authority to place any appropriations reserves on any General
 Fund and Healthy Futures Fund appropriations in Section 1 of this Part of this
 Chapter.

16 Section 5. Transfer Authority Restrictions. Notwithstanding any 17 other provision of law and this Act, *I Maga'låhen Guåhan shall not* be 18 authorized to transfer any General Fund and Healthy Futures Fund 19 appropriations in Section 1 of this Part of this Chapter to any other department 20 or agency of the government of Guam."

Section 3. A new Section 1(m)(7) is hereby *added* to Chapter V of Public
Law 33-185 to read:

"(7) Transfer Authority Restrictions. Notwithstanding any other
provision of law and this Act, *I Maga'låhen Guåhan shall not* be authorized
to transfer any General Fund, Police Services Fund, and Tourist Attraction
Fund appropriations in Section 1(m)(1) to any other department or agency of
the government of Guam."

2

Section 4. A new Section 1(n)(7) is hereby added to Chapter V of Public
 Law 33-185 to read:

"(7) Transfer Authority Restrictions. Notwithstanding any other
provision of law and this Act, *I Maga'låhen Guåhan shall not* be authorized
to transfer any General Fund, Corrections Inmate Revolving Fund, and Safe
Streets Fund appropriations in Section 1(n)(1) to any other department or
agency of the government of Guam."

8 Section 5. A new Section 1(aa)(5) is hereby *added* to Chapter V of Public
9 Law 33-185 to read:

"(5) Transfer Authority Restrictions. Notwithstanding any other
 provision of law and this Act, *I Maga'låhen Guåhan shall not* be authorized
 to transfer any General Fund, Enhanced 911 Emergency Reporting System
 Fund, or F.L.A.M.E. Fund appropriations in Section 1(aa)(1) to any other
 department or agency of the government of Guam."

15 Section 6. Effective Date. This Act *shall* become effective upon enactment.
16 Section 7. Severability. If any provision of this Act or its application to
17 any person or circumstance is held invalid, the invalidity *shall not* affect other
18 provisions or applications of this Act that can be given effect without the invalid
19 provision or application, and to this end the provisions of this Act are severable.
