BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Transfer of Funds from the Guam Economic Development
- 3 Authority to the Department of Administration. Notwithstanding any other
- 4 provision of law, rule or regulation, the sum of Seven Hundred Thousand Dollars

- 1 (\$700,000) of the Annual Community Contribution from the Guam Healthcare
- 2 Development, Inc., dba Guam Regional Medical City, received by the Guam
- 3 Economic Development Authority by the effective date of this Act to September 30,
- 4 2019 shall be transferred from the Guam Economic Development Authority to the
- 5 Department of Administration within five (5) days of receipt of any portion or
- 6 portions received thereof. The Department of Administration shall deposit such
- 7 funds into the Healthy Futures Fund and record the revenue thereof.
- 8 Section 2. Appropriation to the Department of Public Health and Social
- 9 Services for the Medicaid Program. Notwithstanding any other provision of law,
- 10 rule or regulation, the sum of Seven Hundred Thousand Dollars (\$700,000) is
- appropriated from the Healthy Futures Fund in Fiscal Year 2019 to the Department
- 12 of Public Health and Social Services as the local matching requirement for the

- 14 Section 3. Effective Date. This Act shall become effective upon enactment.
- Section 4. Severability. If any provision of this Act or its application to any
- person or circumstance is found to be invalid or contrary to law, such invalidity shall

- 18 the invalid provision or application, and to this end the provisions of this Act are
- 19 severable.
