



AN ACT TO *ADD* A NEW SUBSECTION (m)(5) TO SECTION 1 OF CHAPTER V, PUBLIC LAW 35-36 (THE GENERAL APPROPRIATIONS ACT OF 2020), RELATIVE TO ESTABLISHING THE RATE OF COMPENSATION FOR GUAM POLICE DEPARTMENT CIVILIAN VOLUNTEER POLICE RESERVISTS.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Guam Police Department has instituted a Civilian Volunteer Police Reserve
4 program that augments the work of the men and women in blue who serve our island
5 community daily providing support whenever a call for help is made. Since the

1 inception of this reserve program, volunteers have provided thousands of service
2 hours in the protection of life and property by preventing crime, enforcing the laws,
3 and maintaining order for the residents of Guam.

4 *I Liheslaturan Guåhan* further finds that an administrative oversight occurred
5 when language was not included in the General Appropriations Act of 2020 to
6 establish the rate of compensation for Civilian Volunteer Police Reservists.

7 Therefore, it is the intent of *I Liheslaturan Guåhan* to ensure that these
8 Civilian Volunteer Police Reservists are compensated for the time and efforts they
9 exert in ensuring the safety and security of our island with a commensurate stipend
10 for their contributions.

11 **Section 2.** A new Subsection (m)(5) is *added* to Section 1 of Chapter V,
12 Public Law 35-36, to read:

13 “(5) Guam Police Department Civilian Volunteer Police Reserve
14 Stipends. The Guam Police Department *shall* compensate each volunteer
15 serving in the Civilian Volunteer Police Reserve program who fulfills the
16 requirements for each month’s duty the amount of Five Hundred Dollars
17 (**\$500.00**) for that month, effective October 1, 2019.”

18 **Section 3. Effective Date.** This Act *shall* be effective upon enactment.
