AN ACT TO AMEND ITEM (6) AND ITEM (7) OF §22435(K), CHAPTER 22, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO REALLOCATING THE SUM OF ONE MILLION SEVEN HUNDRED SED EIGHTY-TWO THOUSAND FIVE HUNDRED (\$1,782,500.00) THE DOLLARS OF 2007 BOND 5 THE **DEPARTMENT** OF **PROCEEDS** FROM 3 **INTEGRATED SERVICES FOR INDIVIDUALS WITH** ÿ DISABILITIES TO THE DEPARTMENT OF MENTAL HEALTH & SUBSTANCE ABUSE, FOR THE PURPOSES  $\overline{a}$ OF COMPLYING WITH THE AMENDED PERMANENT **INJUNCTION (DISTRICT COURT OF GUAM CIV01-**00041).

## **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Legislative Finding and Intent. I Liheslaturan Guahan finds that in 2 compliance with and pursuant to the Amended Permanent Injunction (District Court of 3 Guam CIV01-00041) the Department of Integrated Services for Individuals with 4 Disabilities (DISID) is being integrated under the Department of Mental Health & 5 Substance Abuse. In this regard, in order to fully comply with the Amended Permanent 6 Injunction, inter alia, the disbursement of bond monies initially appropriated to DISID, it 7 is now necessary to de-appropriate the funds from DISID and re-appropriate them to 8 DMHSA. 9

10 It is the intent of I Liheslatura Guahan to facilitate the implementation of the 11 mandates set forth in the Amended Permanent Injunction by amending the 12 appropriations, as initially authorized pursuant to P.L. 29-19, accordingly. Section 2. §22435(k)(6) of Chapter 22, Division 2, Title 5, Guam Code
 Annotated is amended to read:

"(6) <u>Two Hundred Seventeen Thousand Five Hundred Dollars (\$217,500)</u>
 [Two Million Dollars (\$2,000,000)] to meet obligations imposed by the
 Permanent Injunction (District Court of Guam CIV01-00041) on the Department
 of Integrated Services for Individuals with Disabilities, provided that said funds
 *shall* only be made available to the Department if the District Court approves its
 revised Guam Comprehensive Integration Plan.

9 Section 3. §22435(k)(7) of Chapter 22, Division 2, Title 5, Guam Code
10 Annotated is amended to read:

- 11 "(7) <u>Five Million Seven Hundred Eighty Two Thousand Five Hundred</u> 12 <u>Dollars (\$5,782,500)</u> [Four Million Dollars (\$4,000,000)] to meet obligations 13 imposed by the Permanent Injunction (District Court of Guam CIV01-00041) on 14 the Department of Mental Health and Substance Abuse, provided that said funds 15 *shall* only be made available to the Department *if* the District Court approves its 16 revised Guam Comprehensive Integration Plan."
- Section 4. Liberal Interpretation. This Act shall be liberally construed so as to
   carry out its purpose in a timely manner.
